I Smt Payel Basak, Wife of Sri Subhra Sankha Ghosh, Daughter of Sri Gopal Chandra Basak, resident of Near Rabindra Sangha Club, Rabindra Nagar, Ward No.21 of S.M.C, P.O-Rabindra Sarani, P.S-Siliguri, District-Darjeeling do hereby inform you that on 27.05.2024 I got married to Sri Subhra Sankha Ghosh, Son of Sri Bhupesh Ghosh, resident of Geetanjali Apartment, Nayabasti, VTC, P.S-Kotwali, District-Jalpaiguri as per Hindu Rituals and customs at Siddheshwari Kali Mandir, S.F Road, Jalpai More, P.S-Siliguri, District-Darjeeling as per Hindu Rituals and customs in presence of few relatives, friends, kiths, kins of both sides and the said marriage was an arranged one, subsequently the marriage was registered on 11.06.2024.

That thereafter on 29.05.2024 the boubhat ceremony was held at Jalpaiguri, before the suhagraat ceremony was held my husband told me that now since I have married now I won't contact my parents anymore and I have to stay as a maid servant in his and his mother's house."

He used to do aggravated sexual intercourse with me as a result I was suffering from immense pain.

After few days of marriage my husband and my mother in law namely Smt Chirashri
Ghosh started to pressurize me to bring a cash of Rs 5,00,000/- (Rupees Five Lakhs)
only from my father but I told them that I cannot say my father as he has given me

enough gold jewellery, steel wardrobe (3 doors), washing machine and moreover my father has organized a big ceremony at Akshay Bhawan, Bakultala More, Rabindra Nagar, P.O & P.S-Siliguri, District-Darjeeling, on 16.06.2024.

After refusal to bring dowry my husband and my mother in law started beating me with fists and blows and my husband kicked me on my stomach on 15.06.2024.

Even then on 16.06.2024 the program was held as scheduled and I tried to cope up with all shortcomings but in vain.

On 18.06.2024 my husband again did aggravated sexual intercourse with me as a result of which I became sick and was taken to a Gynecologist by my parents for treatment. (Prescription attached), I called my husband over phone and told him that I am suffering in pain because of him but he did not care about the pain and said he is happy about my condition and will again do such sexual torturous act if his and his mother's dowry demands are not met.

I being frustrated of the physical, mental and sexual tortures and for the demand of dowry is lodging this present complaint against my husband and mother in law so that they can be booked as per the law of the land.

Please treat this as very urgent and act accordingly.
