Siliguri, Pin 734004, in the District of Darjeeling and her mother namely SMT CHUNCHUN PRADHAN, resident of Uchorangeti, Banarhat, Pin:- 735202.

Respected Sir/ Madam,

That I SMT KANKAN DAS W/o Deepak Kumar Das, resident of Thapa Manson (Third Floor), APC Sarani by lane, ward No. 29, Siliguri, Souboni saka P.O. & P.S. Siliguri, Pin 734004, in the District of Darjeeling would like Us muchiquimto lodge a written complaint against my said daughter in law and her mother named above to the effects as follows:

1. That before mentioning the facts of this complaint I would like to SILIGURI WOMEN P. S. mention that my husband namely Deepak Kumar Das is a senior siliguri police commissionerate citizen aged about 68 years and we both are suffering from several health issues.

- 2. That I am a housewife and my family consist of my husband namely Sri Deepak Kumar Das, my son Sri Dipanjan Das and my daughter in law Smt Anuradha Pradhan Das @Sneha Pradhan.
- 3. That on 2<sup>nd</sup> December 2018, marriage in between my son i.e. Dipanjan Das and my abovementioned daughter in law i.e. Anuradha Pradhan Das @Sneha Pradhan was solemnized by following the Hindu rites, customs and rituals at Mainak Hotel, Siliguri and thereafter they started to live as husband and wife at my above said residence which is a residential Flat owned by my husband. It is pertinent to mention here that all the marriage expenses of both sides were borne by me and my husband along with our son whereas the family of the abovementioned daughter in law Smt Anuradha Pradhan Das @Sneha Pradhan did not bear a single penny in the aforementioned marriage expenses. Further, it is pertinent to mention here we have also given all the gold jewelry that

my daughter in law wore during the marriage including three gold necklaces including a gold locket, one gold mangal sutra, two gold bangle, 3 gold rings at the time of marriage.

- 4. That at the time of above said marriage in between my son and my daughter in law, her family members i.e. the mother and other guardians of my daughter in law introduced her to be very cultural, polite and calm woman, however, after marriage I found my daughter in law to be a very short-tempered lady, having no respect towards her elders or her in-laws. With the passage of time, I came to know about her actual conducts and character.
- 5. That from the very beginning without any rhyme and reason my said daughter in law used to abuse me, my son and my husband with most filthy languages without any reasons and looking such certain things in her behavior I was stunned, flabbergasted, tensed and shocked.
- 6. That my daughter in law from the very beginning showed no interest towards household works and never cooked food not even for her husband and never ever made an effort to do any of the household work. It was I who used to cook for her and wash her clothes including her undergarments, I was hesitant in washing her undergarments in the beginning but she is of such a cruel character that she used to threaten me and my family which caused a fear in me and I complied to do so. It is pertinent to mention here that if I ever asked her to cook food for herself, my daughter in law always had a violent outburst of anger and used to throw utensils kept in kitchen over and many a times at me as well and at the floor and moreover whenever my daughter in law found me alone in the house, she always made huge quarrel and also inflicted several injuries to me and on few occasions threw hot tea over my body. Further my daughter in law has subjected me and all my family members with severe mental cruelty by various ways i.e. on some occasions she mixed dangerous medicines in my water bottle due to which I suffered severe illness and on several occasions she has left the cylinder gas on just with the intention to set our home into burning chamber and on one occasions she mixed dangerous medicines in rice contained as she was caught red handed by me. However just to save my matrimonial home of my son I never took any step against my daughter in law.

daughter in law as she is has a very short temper and can do anything and everything to us. That from enquiry, it has come to our knowledge that aforesaid mother of my daughter-In-law is of same nature and character and further due to said immoral character of said Smt Chunchun Pradhan, her husband has left her since long.

- 14. That Sir/ Madam we beg justice from you, as a common man we cannot stay with her anymore as reasons abovementioned.
- 15. That on the hours of terror, I humbly request your good self to book my daughter in law namely Anuradha Pradhan Das @ Sneha Pradhan and her mother namely Smt Chunchun Pradhan under appropriate provisions of criminal law.
- 16.Sir/ madam I request you to take legal action against them, Sir/ madam please do the needful so that we can live peacefully and fear free life.
