In producing herewith 07 (Seven) arrested accused persons namely (1) Sujit Lama @ Tepa-22yrs s/o Lt Sankar Lama of Baribhasa, New Market PS NJP Dist Jalpaiguri (2) Biki Sahani-20yrs s/o Lt Kapil Sahani of Tikiapara Hatath colony, Ward No-28 PS Siliguri Dist Darjeeling (3) Md Bappa-22yrs s/o Md Rafikul of Tikiapara, Prankrishna colony, PS Siliguri Dist Darjeeling (4) Promod Sahani-30yrs s/o Akhil Sahani of Tikiapara, Hatath colony, ward No-28 PS Siliguri Dist Darjeeling (5) Sujit Shikdar-22yrs s/o Mahadev Shikdar of Khudiram colony, Bagrakote, ward No-18 PS Siliguri Dist Darjeeling (6) Sanjib Das @ Doga-23yrs s/o Sambhu Das of Bagrakote, Chittaranjan colony, Ward No-20 PS Siliguri Dist Darjeeling and (7) Nandu Tirkey-26yrs s/o Lt Saharay Tirkey of Bagrakote, Chittaranjan colony, Ward No-20 PS Siliguri Dist Darjeeling arrested on 30.06.24 u/s- 41 Cr.P.C along with following seized articles viz: -

1. One iron rod measuring about 22 inch (approx) from the possession of accused Sujit Lama @ Tepa which was kept on his right hand.

2. One iron rod measuring about 24 inch (approx) from the possession of accused Md Bappa which was kept on his right hand.

3. One iron made Knife approx 8 ½ inch from the possession of accused Promod Sahani which was kept on his right waist.

4. One iron rod measuring about 28 inch (approx) from the possession of accused Biki Sahani which was kept on his right hand

I, ASI Debasish Das s/o Haripada Das of Siliguri Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 30.06.24 at 00.10 hrs received a sources information that 11/12 youths have assembled at Bagrakote Bus stand under. Siliguri PS for making preparation to commit dacoity in a house at Siliguri PS area. The fact was diarized in G.D vide Siliguri PS GDE No. 1509 Dated 30.06.24 Subsequently after sharing the information with my superiors and as per their direction, at 00.20 hrs myself along with ASI Rabin Lama, ASI Subir Sen, CVF/622 Ramanath Barman & CVF/283 Prasenjit Dey along with ASI Nawaz Sarif, with his force (Van officer) kits left for the place to work out the information. This refers to Siliguri PS GDE No-1510 dated 30.06.24. We reached at Bagrakote Bus stand under Siliguri PS at 00.32 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to shown by the source with a strong reason to believe that they were preparing to police has cordoned off, they tried to flee away but on hot chase we managed to

apprehend above noted 07 (seven) accused persons along with seized articles as mentioned above. However, the other 3/4 persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Siliguri PS area. They also stated that one Palash Mondal, Poltu Das, Bishal Routh and one Bhabesh @ Rajkumar Paswan & Badal Rongdar were fled away from the spot.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made in between 01.20 hrs to 03.05 hrs) Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them.

I accordingly brought the arrested accused persons along with seized articles at Siliguri Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit Dacoity in a house at Siliguri PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Sujit Lama @ Tepa-22yrs s/o Lt Sankar Lama of Baribhasa, New Market PS NJP Dist Jalpaiguri (2) Biki Sahani-20yrs s/o Lt Kapil Sahani of Tikiapara Hatath colony, Ward No-28 PS Siliguri Dist Darjeeling (3) Md Bappa-22yrs s/o Md Rafikul of Tikiapara, Prankrishna colony, PS Siliguri Dist Darjeeling (4) Promod Sahani-30yrs s/o Akhil Sahani of Tikiapara, Hatath colony, ward No-28 PS Siliguri Dist Darjeeling (5) Sujit Shikdar-22yrs s/o Mahadev Shikdar of Khudiram colony, Bagrakote, ward No-18 PS Siliguri Dist Darjeeling (6) Sanjib Das @ Doga-23yrs s/o Sambhu Das of Bagrakote, Chittaranjan colony, Ward No-20 PS Siliguri Dist Darjeeling and (7) Nandu Tirkey-26yrs s/o Lt Saharay Tirkey of Bagrakote, Chittaranjan colony, Ward No-20 PS Siliguri Dist Darjeeling and one Palash Mondal, Poltu Das, Bishal Routh and Bhabesh @ Rajkumar Paswan & Badal Rongdar and arrange for its investigation.
