In connection to the above noted subject I, Sunam Prasad, S/O Sri Badri Prasad would like to register my formal complaint against Toto driver for serious injury suffered by my wife, Smt. Sushila Shaw yesterday the details of which is mentioned here under: The accident took place at Milanpally More, Near Sushil Pharmacy, S.M.C., Siliguri at about 7.30 p.m. yesterday, 29<sup>th</sup> of June 2024. My wife, Smt. Sushila Shaw and her sister in laws, Smt. Poonam Singh and Jyoti Shaw while crossing the road at the above mentioned place was badly injured due to an approaching speeding Toto. The toto nearly ran onto them with high speed without sounding horn and suddenly applied breaks due to which my wife was thrown on the ground and suffered severe injuries mainly on her head. She was rushed to Arogya Niketan Nursing home where five stiches had to be applied on her head at d her situation is still not out of danger. Smt Jyoti Shaw was also injured due to collision with toto. The menace of rash driving by toto drivers has become serious problem and causing life risk to innocent commuters. We are a three member family having a daughter of age 2 years and five months. You can understand how difficult will now be for us for next many days which is only due to the inhuman behaviour of one person – the toto driver

I hereby lodge a formal complaint against the toto driver for causing injur, to my wife and the problems faced thereafter and request you to find him and take necessary action which shall remain as an example for all such toto drivers for which innodent peoples

suffer.
