That till the financial year 31/03/2022, the total outstanding due amount was Rs. 12,03,673/and they have acknowledged the accounts maintained by me on 29/04/2022 and admitted the dues. That thereon 21/11/2022, I have submitted a request letter requesting under the head "Reminder for payment" to them and even after receiving the said request letter, they paid no heed to it and neglected to pay the outstanding amount to me.
