That my marriage was solemnized on 14/07/2017 and again our social marriage was solemnized on 15/11/2018 with Ankit Kumar Jaiswal, Son of Sri Vide (In (W) In side 2nd building, P.O Sevoke Road, P.S Bhaktinagar, Dist- Jalpaiguri, Pin-12 Edale GFM and and after my marriage i started my nuptial life alongwith my husband and other in-laws in my matrimonial house.

That after Four month's of my Social marriage i.e month of April, me and my husband went to Mumbai for the treatment of my mother-in-law. During that period my husband went to Kolkata for two times to meet his ex-girlfriend. It is also added further that since after my marriage i discovered that my husband is also having extra marital affairs with different women. my husband conceal the entire matter from me but I patch up the matter and decided to continue my married life happily.

That before my marriage he and his family member's said to my parent's they have permanent residential apartment but after marriage he took me in a rented house and said to me stay here for few month's, after renovation our apartment we shall go there but but passing 1.5 years, i continue my married life in a rented house. When I asking my husband and my in-laws they said to me there silliguri police commissions they are conceal this matter from me and my parent's.

- 4. That it is also added further that my husband took loan from many people and I am fully unknown about this matter. I am fully shocked when the lender came to my rented house and force me to either repay the money or call your husband and this type of threat happened in my day by day life.
- 5. That one day my husband told me I will sort out all the problems as soon as possible, just give me your blank signed cheque of SBI and I trust him and give him the cheque and the lender receive this cheque by my husband and the cheque bounces. After that the lender file a case against me and I am fully unknown about this matter. He had taken loan from many financial institutions like bandhan, ashirbad finance, etc. by giving my documents. Therefor the financial institution threatened me for paying loan amount. So I am fully depressed by mentally pressure and my husband is running away from the above mention financial institution.

- 6. That after my husband sold my all gold Ornament's which was gifted by my parent's but but he did not repay loan. After when i came to know about this matter and asking him where is my ornament's, he has no answer even he used to filthy launguages and started physical and mental torture upon me. After that when I informed this matter to my father-in-law(Jiten Gupta), Mother-inlaw(Sarita Devi), Sister-in-law(Ankita Jaiswal) and being aware of the fact that i have gathered all the information but my in-laws does not believe me even my husband along with the above mentioned in-laws started physical and mental torture upon me and demanded several things like TV, Dinner Set, Refrigerator, Kitchen Appliances like Valuable Products & along with a sum of Rs. 2,00,000 as dowry.
- 7. That after I got pregnant on 2020 and we got a male child on 2021 namely Yohan Jaiswal (DOB- 08-03-2021). After that I thought that everything will be normal but I was wrong they started more physical and mental torture upon me. They never take care of my child, never help me even they always use filthy languages in front of my husband but my husband never protest my in-laws. My husband has many times tried to choke and drown me to death and they always demanded dowry whenever i refused to Succumb to their illicit demand for dowry, my father-in-law(Jiten Gupta), Mother-in-law(Sarita Devi), Sister-inlaw(Ankita Jaiswal) & my husband tried to choke me to death again.
- 8. my husband deprived me from having food for many days and they as atted me and whenever i confronted them regarding the same My husband and my father-in-law also went to the extent of threatening me to cut me into pieces with saw and in last dipawali, 2023 he drove away me from home and i called my parent and told them about the things going on and when they came rescue me from my in-laws along with my husband drove me from my matrimonial house and also chased my parents with wooden sticks and steel rods with the intension to kill us.
- 9. After that I join a school teacher job in December, 2022 for maintenance my child but my husband blackmail me and harassed/me mentally and physically. After that I leave that job and started living with my family.
- 10. That in the month of may, 2024 my husband suddenly came to my parental house and take my child with him without informing me. After that I call my husband in phone and tell him give back my child, he clearly told me he will not return my child. Being an Indian woman i tried to patch up the matter since the very beginning but day by day the torture become unbearable and for that reason i have been constrained to lodge this complaint.

Therefore, i pray before you to investigate the matter and take necessary legal actions against the said Ankit Kumar Jaiswal, Jiten Gupta, Sarita Devi, Ankita Jaiswal.
