In producing here with the two following accused persons namely (i) Anan Goswami (28 yrs) S/O Jogen Goswami of Debidanga Bazar, Champasari, PS- Pradhan Ngar, Dist.-Darjeeling and (ii) Santalal Rajbhar @ Sintu (30 yrs) S/O Swapan Rajbhar of Bhangapool, PS-Matigara, Dist.- Darjeeling under arrest along with the following articles under seizure viz

(i) One Toto (E-Rickshaw) light gren colour styled as "ETRON".

(ii) One red cvolour Toto (E-Rickshaw) styled as "SODYCO".

(iii) 04 (four) numbers of red colour batteries styled as "DUTEC" Shine- E. Rickshaw Tubular

(iv) 04 (four) numbers of red colour batteries styled as "PANTHER" E- Rickshaw battery,

I, SI Goutam Mallik of Pradhan Nagar PS, SPC would like to lodge this written complaint against the following two accused persons namely (i) Anan Goswami (28 yrs) S/O Jogen Goswami of Debidanga Bazar, Champasari, PS- Pradhan Ngar, Dist.- Darjeeling and (ii) Santalal Rajbhar @ Sintu (30 yrs) S/O Swapan Rajbhar of Bhangapool, PS- Matigara, Dist.-Darjeeling to the effect that on 10.07.24 at 22.45 hrs I, received a specific source information that two persons came at Regulated market with two numbers of stolen Totos (E- Rickshaw) for its clandestine disposal. Accordingly, I diarized the fact in General Diary vide Pradhan Nagar PS GDE No 559 dated 10.07.24 and informed the fact to you. Subsequently, being directed by you, I along with SI Bandhan roy, ASI Biplab Kr Das, C/1413 Sujit Sarkar, C/1419 Ashis Roy, C/1446 Nirmal Roy and C/1416 Dilip Barman all of Pradhan Nagar PS, SPC left for Regulated market under PS. Pradhan Nagar, Dist. Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No. 560 dated 10.07.24. I also informed one Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling over telephone and directed him to come to Regulated market with his video camera for the purpose of video graphs if required. I also directed night RT van officer ASI Sanjib Mukharjee to come to Regulated to assist with us. On way, I briefed all the Police personnel sharing the information in hand. At around 23.05 hrs we arrived at Regulated market. After arrival at Regulated market, I contacted two independent local witnesses namely (i) Ajoy Mahato (34 yrs) S/O Rameswar Mahato of Pokaijote, PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Bipul Biswas (42 yrs) S/O Bhanulal Biswas of ice factory Road, Pokaijote, PS- Pradhan Nagar, Dist.- Darjeeling and shared the information with them and requested them to remain present and act as wintness if any search and seizure would have to be made, upon which they agreed. At around 00.05 hrs on 11.07.24 the above noted camera man arrived at Regulated Market and contacted with me. I briefed him regarding his role to play properly.

At around 00.15 hrs, as pointed by the source, I found that two persons were moving suspiciously near R.K. Mobile at Regulated Market and also noticed that, two numbers of Totos (E- Rickshow) parked in front of R.K. Mobile, Regulated Market. We cordoned the place with due care and caution. On seeing police personnel, they tried to flee away from the spot but we managed to apprehed them. Thereafter, we disclosed our identities as Police personnel (as we all were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search, I recovered two numbers of Totos (E. Rickshaw) and eight numbers of E-Rickshaw batteriess from their possessions. On further interrogation, they furnished incoherent statements and finally confessed that they had stolen two numbers of Totos (E-Rickshaw) and came there for selling the same clandestinely along with the batteries. On demand they failed to produce any document in respect of two numbers of Toto's (E- Rickshaw) and eight numbers of batteries.

Accordingly, I seized the above mentioned articles from their possessions under proper seizure list in between 00.05 hrs to 00.35 hrs, duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of areas observing all the formalities of arrest. They are informed over their ground of arrest. The whole process of search and seizure were made under the coverage of video graph by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS- Siliguri, Dist – Darjeelinging as per BNSS. I, accordingly brought the above mentioned two (02) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. During the course of interrogation, it is revealed from the arrested accused persons that they had stolen two numbers of E-Rickshaws with batteries and came there for the clandestine disposal of the same for their wrong full gain.

Hence, I, pray before you that a specific case under proper sections of law may kindly be started against the following two (02) arrested accused persons namely (i) Anan Goswami (28 yrs) S/O Jogen Goswami of Debidanga Bazar, Champasari, PS- Pradhan Ngar, Dist.-Darjeeling and (ii) Santalal Rajbhar @ Sintu (30 yrs) S/O Swapan Rajbhar of Bhangapool, PS-Matigara, Dist.-Darjeeling and arrange for its investigation.
