Respected Sir,

With due respect I, Smt. Sandhya Roy, a resident of 1NoDabgram, Rajiv Gandhi Street, P.O. Rabindra Sarani, Udayan Colony, Siliguri, District Darjeeling, Pin: 734006, West Bengal, would like to formally lodge an FIR against my neighbors, Ram Podder, Kanok Podder, Debangana Podder, and Priyangana Podder, all residing at the sameabove-mentioned address as of mine.

For an extended period, Debangana Podder, along with her family, has subjected my family to severe emotional, verbal, and physical assault. The nature and intensity of their actions have escalated recently to an unbearable level. They have been engaged in spitting at us and using highly vulgar and demeaning languages, including calling me and my daughter "prostitutes of Khalpara" and making derogatory remarks such as "What's your rate?" Their menace continues even at night, where they often throw stones at our house, causing significant distress and fear for our safety. These behaviors are entirely unacceptable in a civilized society.

The situation escalated alarmingly on the night of 14.07.2024 at around 9:30 pm, when my husband, Sri Raghunath Roy, aged about 65 years, who issuffering from high blood pressure, diabetes and other issues related to old age was sitting in the verandah after his dinner. Suddenly I heard my husband's loud scream crying for helpthen I along with my daughter Nupur Roy Chowdhury rushed towards the verandah and saw that my husband was knocked down to the ground by Priyangana Podder and her other family members as mentioned above. He was being heckled, verbally abused

andmercilesslyassaulted by them. When we tried to rescue him, they resorted to violence with us as well and pushed me and my daughter on the ground.

It is pertinent to mention here that during the scuffle one Debangana Podder deliberately snatched my Gold Chain worth about Rs 45,000 /-. Additionally, they have damaged several personal properties, including our scooter. They have also threatened to murder my husband by hitting his head with a heavy wooden plank. This incident has left him mentally traumatized and physically vulnerable. Their abusive behavior extends to our guests as well, who have also been subjected to their harassment.

Their actions have instilled a profound sense of fear and helplessness within my family. We are living under constant threat and distress, which has severely impacted our mental and physical well-being. We are also apprehending threat to our lives as they have been continuously intimidating our entire family.

Hence, I earnestly request you to register my formal FIR under Sections 79 for outraging the modesty of any woman by uttering words,115(2) for voluntarily causing hurt,304(2) for snatching my Gold Chain, 329(3) for Criminal Trespassing, 351(3) for Criminal Intimidation by threatening to cause death or grievous hurt of Bharatiya Nyaya Sanhita, 2023and any other provisions of law as you may deem fit. I further request you to take strong and deterrent action against the afore mentioned persons in order to ensure the safety and security of my family and to restore peace in our lives.
