Sir,

I Smt Tanushree Karmakar, Wife of Sri Rajesh Dey Sarkar, Daughter of Late Tarini Karmakar, resident of Khudirampally, P.O & P.S-Bagdogra, District-Darjeeling do hereby inform you that yesterday at about 11:45 P.M I received a call from Sri Pranay Singh (shop keeper of a pan shop at Station More, Bagdogra), he informed me that 15-20 miscreants came in a Hyundai Venue (blue colour) and in 6-7 motorbikes.

The miscreants abducted my husband and started grievously hitting him with iron knuckle dusters, iron made bike soccer's, iron rods, and one of them brandished fire arms to my husband.

My husband was abducted and subsequently taken near Gossainpur Milani Club wherein he was grievously assaulted, as a result of the grievous hurt my husband sustained 4 (four) stitches in his forehead, swelling in head, injury in backbone and right shoulder and in private part, the miscreants did grievously hurt my husband with an intention to kill him and after my husband became senseless the miscreants presumed him to be dead and threw him off from the running vehicle (hyundai venue), one person named Palash @ Santu and Sri Subhajit Ghosh rescued my husband and took him to North Bengal Medical College and Hospital, wherein my husband regained consciousness and parrated me the whole incident as how he was saved by whiskers from being murdered. My husband is battling with his life and is presently admitted at Galaxy Nursing Home, Bagdogra in Intensive Care Unit as bed in Intensive Care Unit of North Bengal Medical College and Hospital was unavailable.
