Sir,

I, Meghashri Pradhan, Daughter of Late Lalit Mohan Pradhan, One of the Director of Embark Institute Private Limited, Resident of Ambakay-I Dungra Khasmahal, Lower Dungra Busty, Kalimpong P.O. & P.S. Kalimpong, District- Kalimpong, Pin 734301 in the State of West Bengal would like to state you that I along with Kushal Rai, Son of Sri Hemant Rai, Resident of Methibari, above Embark Institute, P.O. Sukna, P.S. Pradhan Nagar, Dist- Darjeeling, Pin-734009 had incorporated a company namely, Embark Institute Private Limited situated Behind SBI Salbari Branch, Methibari, P.O. Sukna, Dist- Darjeeling, Pin- 734009 in the year 2018 since then we have been working as director of the said company. That I and Kushal Rai was holding a joint account being account no 120002381279 in Darjeeling District Central Cooperative Bank Ltd. Salbari Branch.

That I for the very first time on 25.08.2023 came to know that my signature is being forged and used in the account therefore I wrote a mail to the abovementioned bank from my mail account embark.meghashri@gmil.com to bank's mail account i.e. salbaari@ddcbl.com to change my signature in my bank account. That I again came to know that several cheques has been issued and transactions has been made in the said account forging my signatures. That on 23.02.2024 I wrote a complaint to the manager of the bank against forging of my signature and misuse of my joint account. That I had again sent a notice to the bank through my Advocate and thereafter the account got freezed and an apology letter was submitted by Kushal Rai to the Bank.

That again yesterday ie. 15.07.2024 I discovered that Kusal Rai forged my signature in the diploma certificate of student named Miss Doji Lamu Dukpa and also he has forged my

signature in several other certificates of the institute. Despite my demand that he cease this activity, he refused and asserted that I had no recourse left with no alternative I am compelled to lodge this formal complaint to seek necessary action against Kushal Rai to safeguard my rights under the law.
