Subject: Urgent Complaint regarding Continuous Harassment and Threats by Vishal Chauhan, Son of Lakhbir Chauhan, Resident of Bengdubi Cantonment.

Respected Sir/Madam,

I, Divya Gupta, daughter of Dinesh Prasad Gupta, resident of Grace Home, Tea Auction Road, Mallaguri, District: Darjeeling, writing to bring to your immediate attention the relentless harassment, intimidation, and threats I am facing from Mr. Vishal Chauhan, son of Lakhbir Chauhan, a resident of Bengdubi Cantonment, despite having previously filed a complaint against him at your Cyber Police Station (Cyber P.S Case No: 42/2024) in Siliguri in 19th March,2024.

Mr. Vishal Chauhan was released on bail following my initial complaint dated 26.03.2024 lodged before the Cyber Crime P.S., Siliguri, and since then, he has escalated his harassment through various means. Initially, he used Facebook to harass me, and subsequently, his mother has contacted my friends using her phone number.

On 15th July, where he appeared in front of my office in Mallaguri and made direct threats. On 15th July, he even brought his bike in front of me and issued a direct threat to withdraw my case I will be responsible for whatever wrong he will do to my family. Most recently, on 17th July, Vishal Chauhan resumed his stalking and intimidation tactics. He circled my office twice and sent someone to inquire about my presence inside the office.

Today on 19th July, around 7:20 PM, His acts and conduct went to extremely high-level when all of a sudden he along with some of his friends came in front of me in an autorickshaw while I was heading towards My home and block my way and started threatening me verbally that if I don't go with him then I have to face dire consequences, and when I refuse to go with him, he started pulling me by forcefully, holding my hands and also in some other parts of my body. Not only that when I continue to protest this actions by shouting he also further threatened me that if I do not stop shouting, then I have to face consequences after which I will not be able to show my face in the society and also threatened me that he will publish my obscene photographs in the public portal, and then no authority will be able to help me and my family. That hearing

such hue and cry somehow people around me gathered and stop said Vishal Chauhan from forcefully abducting me.

Therefore, I urgently request your immediate intervention and necessary action against Vishal Chauhan to ensure my safety and well-being. I am willing to cooperate fully with your investigation and provide any additional evidence required to support my complaint.

Thank you for your prompt attention to this matter. I trust that you will take swift and effective measures to bring an end to Mr. Vishal Chauhan's illegal activities and protect my rights.
