With due respect I Nikhat Parveen w/o Ekrar Ahmad residing at R.P Sarani Dangipara, Siliguri like to draw your kind attention on the following effect that My husband and his cousin brother live in the above noted address since long and though it is a co joint property on 26th December 2019 an agreement made between My father in law Reyaz Ahmad and My aunt in law Nurjahan Begum w/o Late Ejaur Rehman with the intervention of the repeated members of our locality, and it was clearly mentioned that 79 \* ×5 \* feet common passage from the SMC Road up to the land of jointly use and occupying by the sons of Reyaz Ahmand and sons of late Ejazur Rehman and no party shall raised any objection in respect of the said common passage.

But on 20.07.2024 when my husband Ekara Ahmad installed a Tin shed in our Portion suddenly Ziaur Rheman and his wife using filthy languages from his room when my husband defend him Ziaur Rehman came with dare consequences and also threatened by saying that if my husband installed the tin shed he immediately without informing us, will broke it. But my husband did not stop the work though it is installed in our Portion, Then after few hours when my husband go outside for his work again ziaur Rehman came with 5 to 6 men who resides in his house as tenant and asked me to stop the work and when I defend him, he with violently pushed me as a result I fall down in the floor and after seeing this my 4 years sons try to rescue me ziaur Rhman also beat my son as a result me and my son sustain grievous injury on head and stomach. Beside that the tenants of ziaur Rehman try to broke the shed with the help of bamboo sticks. When I started shouting, the other family members came and rescue me and ziaur Rehman and his tenants fled away. Then the my family members took me and my son to Siliguri District Hospital where my treatment is going on. I also mentioned here that I delivered a child three months ago through cesarean delivery as a result I got to much pain on the stomach.

Therefore I request you please look into this matter as soon as possible and take proper legal action on it and I am very afraid and ashamed by thinking that this kind of the control of
