In producing herewith five (05) accused persons namely (i) Sukumar Das (24 yrs) S/O Lt Sir, Tapan Das of Santipara, PO+PS+Dist.- Aalipurduar (ii) Mangal Mahato (31 yrs) S/O Late Sonelal Mahato of Banarhat Bazar, PS- Banarhat, Dist.- Jalpaiguri (iii) Suraj Chhetri (26 yrs) S/O Late Sasthi Chhetri of Jyoti Nagar Colony, Ward No-04, PS- Siliguri, Dist.- Darjeeling (iv) Md Budha (22 yrs) S/O Md Hafijuddin of Mallaguri Ratanlal Busty, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling and (v) Md Safikul @ Takla S/O Lt Md Noor Islam of Mallaguri Ratanlal Busty, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following articles under seizure viz :- (i) 01 (one) iron made sharp cutting weapon called as "HASUA" measuring 23 inches in length including its wooden butt, (ii) 01 (one) iron made sharp cutting weapon cased as "KHUKRI" measuring 14.5 inches in length including its wooden butt, (iii) 01 (one) iron made hammer with its bamboo made handle measuring 10.5 inches in length (iv) 01 (one) iron made sharp cutting weapon called as "KHUKRI" with its cover measuring 10 inches in length including its butt (v) one iron made Plus with its red handle (vi) 01 (one iron made rod measuring 10 inches in length and (vii) one torn nylon bag. I, SI Goutam Mallik of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted five (05) arrested accused persons and their 06/07 unknown associates who involve in this crime to the effect that on 24.07.24 at 00.10 hrs received a specific source information that about 11/12 miscreants assembled in the varanda of Simulguri S.S.K. near Simulguri Football ground under PS- Pradhan Nagar, Dist.- Darjeeling equipped deadly weapons and were taking preparation for committing dacoity at Samar Nagar and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No 1911 dated 24.07.24. As per your kind order and direction, at about 00.25 hrs. I along with with SI Bandhan Roy, ASI Biplab Kr Das, C/1169 Prasenjit Barman, C/1413 Sujit Sarkar, C/1119 Tamnoy Roy and C/1416 Dilip Barman all of Pradhan Nagar PS left for Simulguri under Pradhan Nagar PS, Dist.- Darjeeling by Govt. Vehicle with the Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.-Darjeeling with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No. 1913 dated 24.07.2024. On the way, I briefed all the Police personnel sharing the information in hand and also informed RT van officer SI Biswajit Biswas of Pradhan Nagar PS and directed him to come to near Simulguri football ground to accompany with us. At around 00.55 hrs we arrived at near Simulguri football ground and contact with my source while he stated that the miscreants assembled in the veranda of Simulguri S.S.K. Then, I contacted with independent witnesses (i) namely Rajesh Roy (38 yrs) S/O Chulai Roy and (ii) Tapan Deb (40 yrs) S/O Late Sachindra Deb both of near Simulguri Football Ground, Dakshin Samar Nagar, PS- Pradhan Nagar, Dist.- Darjeeling and I informed them regarding the information and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed. At around 01.10 hrs night RT van officer SI Biswajit Biswas along with his force arrived there and accompany with us. I briefed him and his team properly.

Thereafter, being pointed by the source from a considerable distance we noticed that some persons assembled in the veranda of Simulguri SSK near Simulguri Football ground and they were whispering in a very low voice. We cordoned the place with due care and caution. On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehened above noted five (05) accused persons while 06/07 others managed to fled away from the spot. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered one torn nylan bag containg the above noted weapon of offence from Sl No (i) to (vi) from their joint possession. On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 06/07 of their associates assembled there and were making preparation for committing dacoity at Samar Nagar and its surrounding areas.

Accordingly, I seized the above mentioned weapons of offence from their possessions under proper seizure list in between 01.45 hrs to 02.10 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. The whole process of search and seizure were made under the coverage of video graph by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS- Siliguri, Dist.-Darjeelinging. I, accordingly brought all the five (05) arrested accused persons along with seized articles at Pradhan Nagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons, that they along with their 06/07 associates assembled there and making preparation for committing dacoity at Samar Nagar and its surrounding areas.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted five (05) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night for taking preparation to commit dacoity in a nearby affluent area at Samar Nagar and its surrounding areas.

Under the above circumstances, I therefore pray before you that a specific case under proper section of Law against may kindly be started against the above noted five (05) arrested accused persons namely (i) Sukumar Das (24 yrs) S/O Lt Tapan Das of Santipara, PO+PS+Dist.- Aalipurduar (ii) Mangal Mahato (31 yrs) S/O Late Sonelal Mahato of Banarhat Bazar, PS- Banarhat, Dist.-Jalpaiguri (iii) Suraj Chhetri (26 yrs) S/O Late Sasthi Chhetri of Jyoti Nagar Colony, Ward No-04, PS-Siliguri, Dist.- Darjeeling (iv) Md Budha (22 yrs) S/O Md Hafijuddin of Mallaguri Ratanlal Busty, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling and (v) Md Safikul @ Takla S/O Lt Md Noor Islam of Mallaguri Ratanlal Busty, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and others 06/07 unknown miscreants and arrange for its investigation.
