I, Ajijar Rahaman, son of Samsuddin Md., and a resident of Mantapara, Kukurjan, Rajganj, Jalpaiguri-735121, hereby lodge a formal complaint regarding a theft incident that occurred today, 23rd July 2024, at approximately 8:30 AM at Krishna Enclave, Phansidewa More, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling, Pin-734011. I work as the Manager of the mentioned premises.

This morning, at around 8:30 AM, an unidentified individual unlawfully entered the premises of Krishna Enclave and targeted the electrical transformer situated within the enclave. The individual dismantled and stole essential components from the transformer, specifically 12 pieces of 300-ampere cut-outs. The theft was brazenly executed in broad daylight, causing significant distress and inconvenience to the residents of Krishna Enclave.

The CCTV cameras installed at Krishna Enclave recorded the entire incident. The footage clearly shows a lone individual, arriving in a bike. The individual can be seen tampering with the transformer. The CCTV footage is available and can be provided to assist in the investigation.

The theft of the transformer components has caused significant distress and inconvenience to the residents of Krishna Enclave. The entire residential area has experienced a power outage, disrupting daily activities and posing a serious threat to the well-being of the inhabitants. Essential services such as water supply, security systems, and household appliances have been adversely affected. The elderly and children are particularly vulnerable to the consequences of this power outage, and there is an urgent need to get a hold of the culprit behind this chaos.

I earnestly request the police department to take immediate and stringent action to investigate this theft. It is imperative to identify and apprehend the perpetrator to prevent such incidents in the future.

I am willing to cooperate fully with the investigation and provide any further information or assistance required.

I trust that the police department will treat this matter with the urgency it deserves and take swift action to bring the culprit to justice.
