Dear Sir,

I, Aktar Sardar S/O Late Abdul Jabbar Sardar, Station Manager attached to Fulbarihat C.C.C under P.S NJP, District:- Jalpaiguri would like to lodge a complaint against Jahangir (full name unknown), resident of Bhandarigach, Balaram, Jalpaiguri under the jurisdiction of Bholer Alo PS, Ambari Outpost.

On 22.07.2024, following a disconnection order issued by the undersigned, representatives of M/S Maa Bipadtarini Construction attached to Fulbarihat CCC, WBSEDCL arrived at Jahangir's premise to carry out the lawful disconnection of electricity due to non-payment of dues amounting to Rs.67246/- with consumer ID-422220986 (consumer id is officially in the name of Abdul Karam, who is no more alive and currently his grandson "Jahangir" is using the same service connection). On upon proceeding the disconnection work, one Jahangir (Full name unknown) charged the representatives of WBSEDCL with wooden beams, passed life threatening warnings and harassed them. The action not only obstructed the official work but also posed a threat to safety and security of the personnel involved.

Therefore, in light of the above, I request you to register an FIR against Jahangir resident of Bhandarigach, Balaram and take strict action to prevent such occurrences in the future.
