Jalpaiguri on 08.06.2020 according to Hindu rites and customs and our marriage was solemnized at Kalibari Mandir, S.F. Road, Siliguri, Dist. Darjeeling.

That after solemnization of marriage, I along with said Liton Saha started to live and cohabit together as husband and wife at their house at 25, Shitala Para, Ward No. 31 of S.M.C., P.O. Siliguri Bazar, P.S. N.J.P., Dist. Jalpaiguri.

That thereafter on 10.12.2020, my father arranged a reception party and family members, relatives and friends of both the parties were present.

- 7) That my husband and his parents also created pressure upon me to bring a sum of Rs.3,00,000/- only from my father for purchasing motorcycle (Royal Enfield Bullet) but when I tried to convince them that my father is not in a position to give money, my husband became very furious and started to beat me.
- 8) That the father-in-law Basu Saha and mother-in-law Anjali Saha also used to torture upon me physically and mentally and also insisted my husband to create torture upon me.
- 9) That on 13.04.2021, my husband and his parents had physically assaulted me and driven me out from their house and threatened me that if I will not bring the said amount from my parents, I will not be allowed to enter into my matrimonial house and finding no other alternative, I stayed at my parental house.
- That thereafter, I came to know that my husband has illicit relation with one girl namely Ayushi Sarkar, Daughter of Subhash Sarkar of Ghogomali Bazar, under P.S. Bhaktinagar, Dist. Jalpaiguri and when I raised protest against said illicit relation of my husband, he became furious and physically assaulted me mercilessly and he along with his family members driven me out from their house on 12.11.2022 and at that time, I was pregnant and since then, I have been residing at my parental house.
- 11) That thereafter, I gave birth of a male child on 27.11.2022 namely Dhiraj Saha at "Matrisadan", Dabgram, under Siliguri Municipal Corporation area and I informed my husband about the birth of the child but he or his family members did not come to see the baby.
- 12) That at the time birth, all the expenses were borne by my father and my husband did not pay any single money.
- 13) That since 12.11.2022 as well as since birth of the child, I along with my minor son have been living at the house of my father and my husband has not been looking after me and our minor son and has also not been paying any maintenance to us.

- 14) That on several occasions, I requested my husband to give maintenance but he threatened me that he will kill me and also my father and cut us into pieces.
- 15) That on 22.07.2024 at about 11:30 a.m., my husband came to my parental house and when I asked my husband to give maintenance to me and my minor son and thereafter, he became furious and started to assault me physically and when my mother came to save me, my husband also misbehaved with my mother.

So, I therefore, request you to investigate the matter and to take necessary legal action against the my husband **Sri Liton Saha**, his father Sri Basu Saha, mother Anjali Saha, sisters namely Karabi Saha and Suravi Saha, all are residing at 25, Shitala Para, Ward No. 31 of S.M.C., P.O. Siliguri Bazar, P.S. N.J.P., Dist. Jalpaiguri-734005 (W.B.) according to law. And for this kindness, I shall much oblige to you.
