With due respect I, Sri Naman Agarwal, S/o Sri Pradip Agarwal, resident of Burdwan Road, P.O.-Siliguri Bazar, P.S - Siliguri, District - Darjeeling would like to state that I am the proprietor of R. S. Enterprises, having its registered office at Ground Floor, Udichi Apartment, Near Das Gupta Optical, Babupara, Siliguri, P.O. & P.S - Siliguri, District - Darjeeling. One Sri Ramji Mishra, Proprietor of Proprietor of Ramji Mishra, having its office at K.G. Bhutia, Rinzing Namgyal Marg. Mangan Bazar, P.O. & P.S. - Mangan, District - North Sikkim-737116, was known to me since long due to same nature of business and he came to me and has induced me to sale him PPC Cement in credit with undertaking that he will pay the credit money within 15 days from the date of every purchases and being a business man and considering the relation. I agreed to sale cement to his firm Ramji Mishra and accordingly in the accounting year of 2019 - 2020, the said Ramji Mishra purchased cement worth Rs. 8,76,470/- and out of which he paid a sum of Rs. 3,00,000/- in the said accounting year with undertaking that he will pay the entire balance outstanding money amounting to Rs. 5,70,470/- and against the said outstanding credit money, on 15 - 6 - 2020 he paid a sum of Rs. 1,00,000/- on 21-5-2022 he again paid a sum of Rs. 1,00,000/- and retained the balance money amounting to Rs. 3,70,470/-.

Since 21 - 5 - 2022, on several occasions I have asked and requested him to pay the money but on each and every occasions, he neglected to pay the same and lastly on 11 7 2024 he flatly refused to pay the money and threatened not to call him or visit him in default. I have to face serious consequences.
