The delivery boy arrived at the customer's address at 01.50 PM and delivered the order. The delivery boy reached the customer's address at 2/2 Baghajati colony, near Kanchanjangha Athletic Club at 02.00 PM. The delivery boy received the payment and handed over the food to the customer. The customer paid the delivery boy Rs. 318/24. The delivery boy then left the place. After the delivery boy left, the customer called the delivery boy and asked him to return the extra amount of Rs. 18/24. The delivery boy refused to return the money and the customer became angry. The customer then hit the delivery boy and caused some injuries. The delivery boy then went to the Siliguri District Hospital for treatment.
