Darjeeling, would like to lodge this written complaint before your good authority to the effect that I am a business person and I have been running and carrying a business under the name and style as "Rahul Guha Steel Industries" on and from Kadamtala, Pokaijote, Near Ice Factory, Ward No. 46 of S.M.C., Siliguri, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling. Sir, in course of my said business, since last six months ago, I have engaged one person namely Umesh Chettri, permanently resident of Birpara and presently residing at Behind Sree Guru Vidyamandir, Near Boy's Hostel, Ward No. 46 of S.M.C., Siliguri, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, as my driver.
