N J P, District- Jalpaiguri- like to inform you that my marriage was solemnised with Sri Rakesh Sharma, Son of Sri Naresh Sharma, resident of C/o Sanjay Chakraborty, Milanpally, RBS Club, Mukundadas Road, PO & P.S.Siliguri, District-Darjeeling on dated 25/01/2022 as per Hindu rites and customs at Panchmukhi Bhawan, Babupara, Siliguri.

That after marriage we have been living together as husband and wife at the said rented house at Milanpally, Siliguri, Dist.Darjeeling upto 13.2.2023 and out of said wedlock relationship one male child namely OMANSH SHARMA was born on 13.10.2022.

That soon after the marriage my husband started to misbehaved with me and started to mental and physical torture upon me in different ways, but some how I managed to settled up the tortured of my husband. He also demanded money from my mother time and again .

That on the occassions of the marriage of my younger sister I went to my mother's house at Chunabhati on dated 13.2.2023 and since then I have been compelled to live with my mother at Chunabhati, Dist.Jalpaiguri - as my husband left me my mother's house and he came back to his home at Milanpally.

I have contacted with phone, but he refused to take back me and he also denied to accept me and my minor son as his wife and his son, he also refused to give any furthing for my livelihood.

Now he has not received my phone calls also and ~~when~~ as and when I go to Milanpally at my rented house ,I see that the rooms of my husband locked as such unable to entered into my house.
