Sir,

With due respect I Smt. Rita Kumari, W/o Vivek Chourasia, presently residing at Banofull Sarani, Lake Town, Nabogram, Ward No. 33, P.O. & P.S., N.J.P., Dist.: - Jalpaiguri, would like to draw your kind attention towards the eccived no state on 21.11.2021 our marriage was solemnized as per Hindu Rites and customs in presence of Friends, family members & well-wishers of both The No 2121ch the parties at Kalwar Bhawan, Burdwan Road, Siliguri. It is pertinent to mention 13 los 124 and that during the time prior to marriage i.e., pre-wedding ceremony / family meetings the Middle Man [Ghatak], said that the aforesaid person works in CCN, 25 case No 753 listening and considering the words of the Ghatak the parents of mine had a That cales 124 meeting with the uncle [mama] of the aforesaid person named ANIL 13-85 BAS ALCHOURASIA, thereafter my parents came to know from the uncle of the aforesaid person that the aforesaid person works with his brother named SUNIL CHOURASIA in CCN. Thereafter the mother in law of mine also said that the to 32 chabiled aforesaid person earns a handsome amount of Salary. That at the time of the STAND Jon Darriage my parents gave sum of Rs. 4,00,000/- [Four Lakh] Only to the Investigationaforesaid persons, and my parents also gave one Gold Chain, One Gold Ring to my husband, One T.V., One Freeze, One Box Bed, One Almira, One Showcase, Beddings. Utensils and all the necessary items in order to start a new marital life M as per their demands, also my parents gave 150 Gram Sona to me as in form of Officer-in-Charge wellery at the time our weeding, not only this the parents of mine didn't let the Jalpaiguri Polichead down of the Grooms family members and arranged wedding feat for more ...iguri Metropolitathan 250 people.

But soon after the inception in my matrimonial house within 2 to 3 days, they started abusing and taunting me that Stree-Dhan Properties are not up to the mark "BHIKARI KAH BACCHA" and also demanded Rs. 5,00,000/- [Five Lakh] and at the time of lunch and dinner the aforesaid persons used to malign me that if you want have good food brings us money and fulfil our further demands. It is pertinent to mention that keeping all this hardship and agony aside I believed that someday "Good Light will prevail over them" and if give birth to child then all this torture will set aside. But it is very ironic to state that during the period of my pregnancy when I had encountered physical health issues with regards to puking at that point of time the aforesaid person used to give me medicines some

medicines stating that I am suffering from gas irrespective of the fact and their knowledge that I was pregnant, with an intention to kill my child in my womb itself. I informed all this matters to my sister and at that time my sister and my sister husband came from Jalpaiguri and took the doctor and at that time my brother also came to visit me named Suraj Kr. Bhagat and seeing my condition he took me from Jalpaiguri to Assam. That on 04.02.2023 I gave birth to a female child in Assam and all the wellbeing of mine and my new born child was being borne by my parents. That when my child turned 2 months I returned back to my matrimonial Home after then also the expense of mine and my new born child was being borne by my parents only. That even after all the efforts made by me and my parents for the well-being of my martial life and after all the expenditure incurred still the aforesaid persons kept on demanding further sum of Rs. 5,00,000/- [Five Lakh Only].

It is ironic to state that on 22.07.2024 at about 11:00 A.M in the morning when I open my Almarari it comes to my knowledge that the gold ornaments like one gold pair bala, one gold bouti, one gold mang tika, 4 gold Finger Rings, One pair of gold ear rings, which were given to me at the time of our marriage was missing from its actual place and finding no other way I asked the aforesaid persons regarding the same for which they replied that the gold ornaments are eaten up by them, hearing such words from the aforesaid persons I was in a state of shock and I called my brother in a crying condition and hearing my hue and cry on telephone my brother came to Siliguri. And after the arrival of my brother when my brother asked where are my sisters gold ornaments in which my husband replied that he has kept those Gold Ornaments as mortgage, in which my brother said that he is willing to pay all the debts with regards to the Debt amount in lieu of Gold Ornaments and after that my brother and the aforesaid person i.e., my husband went to Shaktigarh, and after spending the entire day the aforesaid person said to my brother that the person to whom he had kept the Gold in Mortgage has sold those Gold Ornaments.

It is to be noted I believe firmly that the aforesaid persons i.e., my husband and my mother-in-law have stolen my Gold Ornaments and sold the same without my knowledge and since then whenever I ask my gold ornaments the aforesaid persons starts abusing and torture me with filthy languages. Since after this incident I am in a precarious condition and suffering from anxiety, insomnia etc.

Therefore, you are requested to look into the matter and take proper legal action / steps against the above-named persons and recover my Gold Ornaments and also provide me safety with regards to my and my child stay in the aforesaid residence and to take all possible measures as per law.
