Received on I, Amit Kumar Pandey, Son of Late Upendra Pandey, presently residing in a rented 13.08 24 of house at Gossaipur, Bagdogra, District- Darjeeling, since August, 2024 would like to inform you that my wife, Ambika Karki, Daughter of Parbati Karki, resident of Putimari, Bhujiabani, Gossaipur, Block Naxalbari, P.O. & P.S. Bagdogra, District-Darjeeling, Pin- 734014 is continuously committing mental cruelty upon me since our marriage on 29.7.2019. After marriage she compelled me to live as a 'ghar jamai' in her parental house at the address mentioned above. She did not allow me to keep any relation with my widow mother who is a cancer patient and my siblings. That BOR PS cont after the death of my father, entire responsibility of the family came upon my No 286/29 shoulders but my wife did not tolerate if I send money to my mother and on this pt 17.08 24 issue, there used to be fights between us. My mother-in-law namely, Parbati Karki always instigates my wife to torture upon me stating that - she must know how to control her husband and upon her instigation she even assaults me physically. Not only this, my wife and my mother-in-law do the liquor business and have a small shop at Putimari main road. They are doing this business illegally without any license. As this shop is situated near to the house of my wife, my four years minor andowed to daughter also sits in the shop and they have no objection to it. At this age, she knows ASI Nirvad the names of liquor which are available in the shop. When I raise protest to this ch. Pof for considering that it will impact the future of my child, they blatantly shout at me using abusive language. My wife blackmails me by saying that she will lodge false criminal cases against me.

That I pay educational expenses for my child and I cannot tolerate she growing up in such bad environment. So considering this in the month of May, 2024, I told my wife that I will shift to a rented house and even finalised one rented house. When my wife came to know about this, she lodged false 498-A case against me on 20.5.2024 After this, she told me that she will withdraw the case and mend her ways. But she did not rectify herself and constantly used to abuse me and my elder daughter and being compelled I took a rented house at Gossaipur on August, 2024 and even asked my wife that if she wants then she can stay with me with my two children in a separate rented house. I told this considering the future of my two children. That my wife was adamant and she threatened me that she has lodged only criminal case against me, now she will lodge false criminal case against my mother and unmarried daughters, who are residents of NJP, District- Jalpaiguri. She gave me numerous threatening messages and threatened me over phone.

That I am a government employee working in Indian Oil Aviation Office, Bagdogra Airport and she even threatens me that she will eat my job if I do not return back and stay with her in her mother's house at Putimari, Bhujiabani, Gossaipur, Block Naxalbari, P.O. & P.S. Bagdogra, District- Darjeeling, Pin- 734014 On 14.8.2024 around 3 to 3.30 p.m. she went to the extent of coming to my office/workplace searching for me with my minor daughters. She entered the main gate and started

calling my name and used abusive language against me in front of office security guard namely, Nauraj Chettri. On being informed I came to her and I saw my 8 months old daughter crying as my wife mercilessly made her lie on the ground in the scorching heat. I rushed to my daughter and tried to hold her up. But she did not allow me and hit me with fists and blows. I not only suffered injury in my right index finger but it caused immense embarrassment to my dignity, reputation and selfrespect at my work place as the said incident took place in presence of office security guard, apprentice Uttam Sarkar, Contractual worker Amit Singha and Mukul Roy and Supervisor Subho Ghosh.

As I was having pain in my body, I showed in government hospital at Bagdogra on

Even after this my wife is continuously sending me threatening audio messages over phone. She is raising false allegations against me and threatening me that she has managed the residential address of my mother and now she will lodge false complaint against my widow mother and unmarried sisters after entering their house.

Being compelled, I am lodging this FIR against my wife namely, Ambika Karki and my mother-in-law namely, Parbati Karki, who always instigated my wife to torture upon me.

Namely, look into the matter and take necessary action against my wife and motherin-law.
