I SI Pradip Singha presently posted as Siliguri PS, SPC do hereby lodge this complaint against 1] Dilip Mahanta S/O- Subodh Mahanta of Champasari, Ward No-46, PS- Pradhan Nagar, Dist-Darjeeling, Leader of Bharatiya Janata Party (BJP), 2] Lalbabu Sha, Leader of Bharatiya Mahila Morcha, 3] Sanu Baidya 4] Mithilesh of Tikiapara and others of Bharatiya Janata Party to the effect that today on 22.08.2024 approx 120-130 supporters of Bharatiya Janata Party(BJP) of Darjeeling District Committee gathered at Baghajatin Park, under Siliguri PS jurisdiction and at around 14.30 to 15.00hrs hrs they arrived at Siliguri Mahakuma Parishad gate and tried to enter to the premises of SMP to show demonstration against C.M.O.H, Siliguri over the issue of R.G.Kar incident. They were carrying banner & flags of Bharatiya Janata Party (BJP).

Already many officers and forces consists some Lady Officer and force were deployed in front of Siliguri Mahakuma Parishad to maintain Law and order situation.

Subsequently deputed police officers and force available there politely prevent them to maintain law and order situation. Suddenly some of the supporters of BJP got more furious and break the Police cordon and entered into the premises of CMOH office at Siliguri Mahakuma Parishad. On reinforcement other supporters of BJP started to leave the place carelessly and broke the window glass of the building of Siliguri Mahakuma Parishad by punching.

Hence, I request you to start a specific case under proper section of law and take proper legal action against the above noted accused persons namely 1] Dilip Mahanta S/O- Subodh Mahanta of Champasari, Ward No-46, PS- Pradhan Nagar, Dist- Darjeeling, Leader of Bharatiya Janata Party (BJP), 2] Lalbabu Sha, Leader of Bharatiya Mahila Morcha, 3] Sanu Baidya 4] Mithilesh of Tikiapara and others of Bharatiya Janata Party for deterring Police personnel to perform their lawful duties, damaging of govt. property and blocking the free flow of traffic on public road.
