I beg to state that on today i.e. 23.08.2024 at about 13:15 hrs I received a source information that one person kept some stolen lighter and Cigarette in his rented house situated at Girish Ghosh Sarani, Hakimpara, Ward No. 16, PS- Siliguri, Dist-Darjeeling. Hence I diarized the matter vide EB, SPC GDE No. 131 Dt. 23.08.24 and informed the matter to ACP EB, SPC and as per his instruction myself along with Inspector Samrat Mitra, ASI Arghya Das both of EB, SPC left EB Office to proceed Girish Ghosh Sarani, Hakimpara, Ward No. 16, PS- Siliguri, Dist- Darjeeling to execute the information. This refers EB, SPC GDE No. 132 Dt. 23.08.24 and C.C. No. 56/24 Dt. 23.08.24.

At about 15:05 hrs we reached at Girish Ghosh Sarani, Hakimpara, Ward No. 16, PS- Siliguri, Dist- Darjeeling and as per shown by my source, we entered into rented house of Mofiur Rahaman situated at 32 Girish Ghosh Sarani, Hakimpara, Ward No. 16, PS-Siliguri, Dist- Darjeeling and found that

- 36 (Thirty Six) pcs pitch board cartoon each containing 20 (Twenty) boxes having 50 (Fifty) pcs of Lighter (marked as Made in China) total 36000 (Thirty Six thousand) pcs of China made Lighter,
- 24 cartoon boxes having 50 (Fifty) long boxes each boxes containing 20 Cigarette packet styled as "WIN",
- iii) 45 cartoon boxes having 50 (Fifty) long boxes each boxes containing 20 Cigarette packet styled as "PARIS" and
- iv) 420 Cigarette packet styled as "KHUKRI" had been kept in that place.

During enquiry caretaker of the room Prafullya Roy S/O Lt Jogendra Roy of Ambikanagar, Sashan Basty, PS- New Jalpaiguri, Dist- Jalpaiguri informed that the owner of the rented room as well as articles are of Mofiur Rahaman of Bidyapith Apartment, Dangipara, PS- Siliguri, Dist-Darjeeling. On demanded Prafullya Roy could not produce any documents in support of above noted articles. The owner of the articles namely Mofiur Rahaman did not turn up to produce any documents. He had abscond himself to avert Police arrest. Accordingly Mofiur Rahaman stored the huge lighter and Cigarette in his custody as stolen, which is combustible and endanger for human life. The cigarette packets also do not contain pictorial warning as specified in COTPA Act.

In this fact and circumstances I pray before you that kindly lodged a specific case against Mofiur Rahaman of Bidyapith Apartment, Dangipara, PS- Siliguri, Dist- Darjeeling and others for illegal custody as receiver of stolen properties, keeping inflammable articles and endangering human lives and storing and dealing in cigarettes not containing pictorial warning as per COTPA Act.
