

# The humble Complaint of the above named Complainant Most Respectfully States: -

- That the Complainant is peace loving and law abiding citizen of India and residing with the above noted address with unblemished record.
- That the above named accused persons are the owner of the schedule land measuring 6 Bighas 10 Kathas and they have acquired the same by virtue of registered deed of sale being No. 1260 for the year 2010.
- 3. That the complainant state that the aforesaid owner of the land i.e. the accused persons executed an agreement for sale at a Rs. 10,00,000/- (Rupees ten lakhs) per Bigha, in the month of July, 2013 with the complainant and the complainant paid Rs. 2,50,000/- (Rupees two lakhs fifty thousand) only as advance money, but the said agreement could not be regularized due to family problems of the accused, thereafter in the year 2014 the landowner i.e. the accused persons executed an irrevocable agreement for sale at a consideration Rs. 41,00,000/- per Bigha with a power to transfer the land to the intending buyer along with the unregistered power of attorney and on the basis of the said instrument the complainant transferred 5 Khathas of land to Madhu Sharma at a consideration Rs. 10,00,000/- and the complainant has received from him Rs. 8,00,000/- of advance consideration money and at the same way, 5 Kathas of land to Sima Karmakar and Nikhil Saha and after execution of the aforesaid agreement annexed hereunder, the complainant spent huge amount of money i.e. more than Rs. 15,00,000/- for the development of the schedule land.
  - 4. That the agreement entered in between the complainant and the accused No. 1 & 2 with the instruction of active participation of accused No. 3 i.e. Mukesh Sharma who is the son of accused No. 1 & 2.

5. That the complainant further state that the accused persons inspite of subsistence of the aforesaid agreement, transferred a portion of land to different persons and created a third party interest and also transferred the same to one Club in the locality by virtue of deed of Gift with an intention to get support of the Club and ignoring the aforesaid agreement which is illegal and bad in law and thereby deceived the complainant.

It is pertinent to mention that on the very inception of the agreement there was a deception on the part of the accused persons and it is organized crime.

- 6. That the Complainant informed the matter to the I/C, NJP Police Station on 07/06/2024 through speed post vide Speed Post No. RW968839804IN and also complaint before the Commissionerate of Police, Siliguri on 07/06/2024 through speed post vide speed post No. RW968839937IN, but till now no action has been taken.
- That the Complainant is thus compelled to file the present Complaint before the Ld.
   Court.
- 8. That the Petition is bonafide.

In the above premises it is prayed that Your Honour would be kind enough to pass an order directing the I/C, NJP Police Station to investigate the matter and start a case on the basis of the complaint.
