I, JayantaMandal, S/O. Rabi Mandal, resident of N.J.P., Gate Bazar, Ward No.33 of SMC, North Colony, P.S. N.J.P, Dist. Jalpaiguri, would like to state you the following facts:-

That on 27.08.24 at about 130 A.M. I alongwith Parimal Barman, S/O. Pemananda Barman, resident of Siliguri Junction, Gate Bazar, Ward o. 01 of S.M.C., P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, went to the Level-3 Club(Pub), Sevoke Road, Near North City, Siliguri, P.S. Bhakti Nagar, Dist. Jalpaiguri at that time we saw that 9 to 10 peoples were harassing to girls and making videos of those two girls just infront of the Pub and seeing this we tried to stop those people from harassing those girls. Then all of them started abusing me and my friend Parimal Barman in filthy language and asked us to leave from there and finding no other alternative I took out my phone and started to dial Police number for help then they shatched my mobile phone from my hands and broke it down and thereafter they all started to assault us and out of them one BiplabSarkar @ Kangaroo, Son of not known, resident of Mahakal Pally, behind PayelCinema Hall, Sevoke Road, Siliguri, Dist. Jalpaiguri and SankarSarkar, Son of not known, resident of Bidhan Nagar, P.S. Phansidewa, Dist. Darjeeling, assaulted me mercilessly with knife on my neck with intention to murder meand the others assaulted me by belt and by iron knuckle which they were wearing in their fingers and hit on my head so that no chance of my survival remains. Due to assault by knife on my neck by said Shankar Sarkar and BiplabSarkar @ Kangaroo I received severe injuries on my neck and head injuries by the assault of others among their group and blood was pozing out from my head and neck. And seeing that was still alive even after their assault on my neck and head they

again tried to hit me on my neck by said knife with intention to murder me but I protected myself by covering my neck by my hands, if I have not covered my neck by my hands then they would have definitely murdered me by that knife and thereafter, anyhow my friend Parimal Barman rescued me from their hands and we were running away to save ourselves but they continued to chase us and daught hold us at the ground floor of the building of the said Pub and said Shankar Sarkar took out a gun from his pocket and put it on my head and threatened me of not complaining about him to anyone and otherwise he would shoot me by that gun next time and even snatched my chain made of gold from my neck and cash amount 5500/- from my pocket and then went away from there.

- That due to such assault I was seriously injured as such my friend took me to Siliguri S.D. Hospitaland was admitted there and was fighting from death and the Doctor advised that if my condition does not get better in 2/3 hours then I will have to be shifted to North Bengal Medical College and Hospital.
 - That as I was admitted in the Hospital as such I could not lodge F.I.R. at that time. Now after discharge I am lodging this F.I.R.

I, therefore, request to you to kindly take necessary legal action against the aforesaid culprits in the aforesaid matter, for the commission of the aforesaid offences against me.
