Sir,

I Sujay Sarkar, son of Sri Khagen Sarkar, resident of Bidya Chakra Colony, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Darjeeling, Pin – 734001 would like to inform you that on 27.08.2024, I along with my friends Biplab Sarkar, Shankar Sarkar and Biswajit Mandal went to Level 3 Pub situated at Sevoke Road, Siliguri at about 11:30 P.M.

Thereafter, at the midnight on 27.08.2024 at around 01:20 P.M. - 01:30 P.M. when we were leaving the pub premises, just outside the premises, one of my said friends namely Shankar Sarkar was attending a video call and at that time two persons who were later identified as Jayanta Mandal, Parimal Barman and Chiranjit Roy @ Chiru alongwith three to four others suddenly came to Shankar Sarkar and started quarreling stating that he was making their video and were misbehaving with him by manhandling and giving slangs which cannot be uttered in a civilized society. When I saw this incident, I along with my other two friends Biplab Sarkar and Biswajit Mandal went to resolve the issue and when I and my said friends told the said Jayanta Mandal and Chiranjit Roy that Shankar was attending the video call and was not making any video, those persons got furious and started assaulting us with a sharp weapon and due to such assault, I sustained cut injury in my palm and another friend namely Biswajit Mandal sustained blood injury on his head and my other friends also sustained bruises and injury.

Thereafter, the nearby people came and we were rescued and subsequently we rushed to Siliguri District hospital for the first aid/treatment of our friends who sustained blood injuries and I was got two stitches on my hand and Biswajit Mandal was also released after the first aid.

Since today morning, said Biplab Sarkar has been receiving threat calls from a mobile no. 83910-81042 on his phone wherein repeatedly calls are made through the same phone number by different persons threatening to kill us.

Under the above circumstances, I would request you to kindly look into the matter and take immediate steps against the said Jayanta Mandal, Chiranjit Roy @ Chiru, Parimal Barman and their associates as those persons are antisocials and are of dangerous nature and will leave no opportunity to harm/kill me.
