With due respect and humble submission, I Niraj Ray, Son of Late Shyam Nandan Ray, residing at Kaluwa Jote, Naxalbari, P.O. & P.S. Naxalbari, District- Darjeeling, would like to inform and state as follows:-

That my daughter Smt. Nitu Ray is legally married to Rohit Yadav, Son of Binod Yadav resident of Pokhajibote, Champasari, P.O. & P.S. Pradhan Nagar, District Darjeeling on 23<sup>rd</sup> June, 2023. After one month of her marriage, she have been facing difficulty and she is struggling in her marital house as she is being torture mentally and physically by her in-law since day of her marriage. She have been abuse verbally in numerous instances from her husband, father-in-law namely Binod Yadav, brother-in-law namely Sumit Yadav and sister in-law namely Viay yadav & Guddia Yadav. I recently came to know that my daughter have been illegally restrain from moving out side of the house and have been detained and confined in one of the room of the her marital home due to which I am not being able to contact her since past 10 days. Therefore I am worried that she has been wronged by her in-law.

That it is pertinent to mention her that on 19<sup>th</sup> August, 2024 Sumit Yadav call me over the phone and threatened me that they will kill my daughter and also used abusive language toward me and my family and at the relevant time it came to know that they have snatched the mobile phone of my daughter.

Therefore this is for your kind information that under the circumstance mention above I being the legal guardian of Smt. Nitu Yadav is concerned about her safety at this moment and hence I am going to her marital home to bring her back to her parent's house and also further request the authority to provide protection in times of need and look into the matter as soon possible. And for the act of kindness I shall ever remain grateful.
