- I, SI Rantu Haldar of Bhaktinagar Police Station under Siliguri Police Commissionerate would-like to lodge this written complaint to the effect that today on 30.08.24 at 18.35 hrs while performing evening patrolling duty, received a source information that one person namely Sanjib Kumar Darnal (M/29yrs) S/O- Lt Monoj Darnal is selling liquor at Limbu Busty, under Bhaktinagar PS without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with ASI Amardeep Chhetri, C/374 Debraj Biswas had been to the said place to verify the veracity of the information. On reaching there and as identified by the source it found that one person Sanjib Kumar Darnal was selling liquor at Limbu Busty, under Bhaktinagar PS. Subsequently, I along with my officer and force cordoned the place and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted seized articles were found from him. On demand he failed to produce any valid license/papers for selling of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 03(three) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person after observing all formalities. The whole process of seizure has been made in between 19.10 hrs to 19.25 hrs at the spot. The whole process of searched and seizure was video graphed. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 35 BNSS appraising him the ground of arrest.
