

Sir,

I Dipankar Biswas , Inspector of Police, CID, SILIGURI, resident at shaktigarh road no. 2 , PS NJP, Siliguri , District Jalpaiguri, would like to inform you that on 24th August, 2024 at 11:53am ,one Rajesh Das (ph no.9933441737) , a courier agent from Shadowfax Technologies Private Limited , located in Ashigarh, delivered a product in my absence at my residence which was received by my daughter. The product wasn't ordered by me but had my name, phone number and address on it and my daughter paid ₹949 via Googlepay having UPI transaction id – 42371800025. On opening the packet 2 old, used and ribbed clothes were found. Additionally, the outer packaging bore the name of a brand, YOT which I believe to be fake, as my online search yielded no results for such a brand. This further confirms that I have fallen victim to a fraudulent scheme. Some person illegally collected my address and cheated indicating that I have been a victim of a fraudulent activity where the perpetrator has not only wrongfully taken money from me but also sent me items of no value.

I request you that a case may kindly be initiated under proper section of law and request your prompt investigation into this matter to identify and take appropriate legal action against the culprits.
