Sir,

I Mina Gupta, the above noted complainant beg to inform you that the marriage of my daughter, namely, Anand Gupta S/O Sri Prakash Prasad Gupta, marriage was solemnized on 15.12.21 with Tampa Shao D/O Sri Dolgabinder Shao Boro Post office Palar, Ward No-5, P.O. APS-Nal Distt.-Birbhum, under Hindu rites & ritual but since after the marriage my said daughter in-law Tampa Shao, used to torture her husband & us and never maintain us or cook food for us. Due to her atrocities me and my said husband left our house and resided in the house of our daughter for nearly 1½ yrs and over the request of our said son, we refer to our house, but again she started torturing us, with intention to evict us from our house.

Sir, on Dt. 27-08-2024 at about 00:05 Hr when we were at our said house at Tumbajole my said daughter-in-law, started abusing in filthy languages and when my husband protested, she dragged out both of us from our room and started beating us with fist & blows and scratched us with her nail. our whole body and tried to kill us.

We, immediately shifted to ~~Matigara~~ Bir Matigara, Distt.-Birjeeloy and treated ourselves there.

The said Tampa Shao is very desperate & dangerous in nature and she had threatened us for dire consequences, if we will not leave our house. So, please take necessary action against her.
