I, Ranadip Mazumder, S/O:-Late Kalipada Mazumder, AE & Station Manager, Powerhouse CCC, WBSEDCL empowered by The Indian Electricity Act 2003 amended on 2007 do here by writing to report a serious incident that occurred on 31.08.2024 at 5.30 PM at Bhupendra Nagar (Near Bangla School), Dis:-Jalpaiguri, which I believe warrants immediate attention and investigation. The incident involved an accident by unknown vehicle with 8 Mtr PCC pole of our electrical installations, that caused significant damage to WBSEDCL's property and public safety.

As complaint received from different consumers of the said location, Our technical team attend the spot immediately at 6.25 PM and found that one 8 Mtr PCC pole broken with damage of other electrical installation due to accident with unknown vehicle. But, no Vehicle traced at the accident spot during the visit of our technical team. Power Restoration work commenced on 31.08.2024 at about 7.00

The total financial losses caused due to this accident are approximately Rs. 26000.00 (Twenty Six Thousand) only.

Given the potential risks and significant financial implications, I kindly request you that a General Diary be registered regarding this accident. Your prompt attention to this matter is crucial to ensure the safety of the community and the protection of WBSEDCL property.
