In producing herewith following 04 (Four) arrested accused persons along with seized articles from their exclusive and conscious possession under proper seizure list...

1. Mithu Roy (M/32) S/o Ashim Roy of Farabari Nepali busty, P.O Sahudangi, P.S Bhorer Alo, Dist Jalpaiguri, W.B with one old rusted iron crowbar (48 cm approx)

2. Debasis Roy (M/22) 5/o Sudhir Roy of Farabari Nepali busty, P.O Sahudangi, P.S Bhorer Alo, Dist Jalpaiguri, W.B with old rusted Hook Knife with wooden handle (33 cm approx including handle)

3. Injamul MD (M/22) 5/0 Late Bisu MD of Bhutkir Hat, Dangapara, P.O Bhutkir Hat, P.S Bhorer Alo, Dist Jalpaiguri, W.B with Iron Hammer with bamboo handle (30 cm approx, including handle)

4. Hajrat MD (M/23) 5/0 MD Hafish of Harsing Jamadargach, P.O Balaram, P.S Bhorer Alo, Dist Jalpaiguri,

W.B with one black iron pipe (69 cm approx) I, ASI Rana Jadav (9434242480) of Ambari-Falakata OP, PS-Bhorer Alo/SPC, do here by lodge this written complaint to the effect that on 30.08.2024 in course of my night mobile van patrolling duty received secret source information that 10-12 persons had assembled in the bank of Baruapara canal, under Peepal tree, P.S Bhorer Alo, Dist Jalpaiguri, W.B to commit dacoity at the locality. Immediately informed the tip of information to O/C, Ambari-Falakata OP and as per his kind direction I along with, C/505 Tapas Dutta & NVF/036 Ananda Sharma along with Naka Officer ASI Mantu Barman , C/1492 Partha Chakraborty left for Baruapara canal to verify the veracity of information. This refers to Amb\_Fkt OP GDE No. 1057 and MCC No. 1453 dated 29.08.2024. At about 01.35 hrs I along with the police party reached near Baruapara canal and after keeping our vehicle there we proceeded towards Baruapara Canal-banks on foot and being indicated by the source found from the considerable distance that a gang of 10-12 persons were assembled under Peepal tree at the bank of Baruapara canal and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but after a hot chase we manage to apprehend above noted Four persons and other persons fled away from the spot. On interrogation, the apprehended persons disclosed their name and address as noted above and started giving incoherent statement regarding their presence/gathering in the same place also. On further interrogation they stated that they along with Bipul Malo 5/0 Biplab Malo of Ambari, Naltu Sahani s/0 Ram Bdr Sahani, Chandan Roy S/O Parimal Roy & others assembled there in preparation to commit Dacoity. Accordingly, I try to collect independent witnesses from the spot, but due to odd hours and remote location not a single public witness was found from the P.O, therefore, I search them in presence of available police witness and on being search of the apprehended persons, I recovered

- 1. One old rusted iron crowbar (48 cm approx) from the exclusive and conscious possession of accused Mithu Roy, which was kept concealed on the back of his waist.
- 2. One old rusted Hook Knife with wooden handle (33 cm approx including handle) from the exclusive and conscious possession of Debasis Roy which was kept concealed on the back of his waist.
- 3. One Iron Hammer with bamboo handle (30 cm approx, including handle) from the exclusive and conscious possession of Injamul MD
- 4. One black iron pipe (69 cm approx) from the exclusive and conscious possession of Hajrat MD. Accordingly, I seized the above noted recovered articles as per seizure list in presence of available witnesses, duly singed by them. The seizure was made in between 01.55 hrs to 02.06 hrs and I arrested them U/S 43 BNSS after explaining the charges against them.

Under the above fact and circumstances, I pray that a specific case may kindly be started against 1. Mithu Roy, 2. Debasis Roy 3. Injamul MD 4. Hajrat MD 5. Bipul Malo 5/o Biplab Malo of Ambari, 6. Naltu Sahani s/o Ram Bdr Sahani, 7. Chandan Roy S/O Parimal Roy & others under proper Section of law.
