Subject: First Information Report

I the undersigned would like to draw your kind attention towards the fact that I and my wife namely Smt. Chaitali Sengupta, approached one Alokesh Chakraborty, Advocate having chamber at Aadya Vila, 1st Floor, Asha Purna Devi Sarani, Behind Vivekananda School, Hakimpara, Post Office and Police Station: Siliguri, District: Darjeeling, Pin Code: 734001, for filing a defamation suit against one Smt. Jhimli Sengupta (Bhattacharjee) in the month of June, 2023. On consultation with said Alokesh Chakraborty the counsel informed me that for filing such defamation suit there is requirement of paying court fees to the tune of Rs. 1,00,000/- (Rupees One Lakhs) only. According I paid Rs. 1,00,000/- (Rupees One Lakhs) only to the said Alokesh Chakraborty by way of bank transfer from my bank being account no. 30012760249, State Bank of India, Pradhan Nagar Branch under your jurisdiction on 30.06.2023 and 05.07.2023 in two instalments of Rs. 50,000/- (Rupees Fifty Thousand) only each.

The above named accused person also assured me to provide with T.R. 7 Challan after depositing the amount with the Treasury. Since then I have been continuously perusing him to provide such Challan in connection with payment of court fees but unfortunately could not get the same due to non-co-operation from his end. Due to such I got suspicious about the entire incident and tried to enquire from the court about such facts. On enquiry and after obtaining the certified copy of the money suit being no. 109 of 2023 filed before the Ld. Civil Judge, Senior Division at Siliguri, it came to my knowledge that court fees paid

by the Alokesh Chakraborty for filing the aforesaid case was Rs. 10/-only, whereas he took Rs. 1,00,000/- (Rupees One Lakhs) only from me in the pretext of filing court fees for the filing of defamation suit. On further enquiry from other counsel it came to my knowledge that the highest court fees payable before any court in the State of west Bengal is Rs. 50,000/- (Rupees Fifty Thousand) only for any suit whatsoever.

It is pertinent to mention here that aforesaid suit was filed by Alokesh Chakraborty through his junior Natalia Ghosh being enrolment no. F/2512/2414/2018.

I and my wife being a layman and not accustomed with the nittigritty of prevalent laws were ignorant about the fact that in suit for damages with respect to defamation the court fees payable in the State of west Bengal is nil. Whereas, the accused person taking the advantage of such ignorance hatched up an ugly conspiracy to cheat us and dupe Rs. 1,00,000/- (Rupees One Lakhs) only. We being litigants are totally dependent on our counsel and we abide by their advice considering their advice as gospel truth but unfortunately the accused person taking such advantage cheated us and misappropriated such amount as mentioned above.

I being a retired employee and a senior citizen would like to pray before your kind office to take stringent action against the accused person under the suitable provisions of law for cheating, criminal breach of trust and misappropriation.
