

Sir,

In producing herewith the following seized articles with original seizure list, viz:-

(i) 08(Eight) Number of empty Domestic Gas cylinder of HP each weight 14.2 kg.

(ii) 02(Two) Number of empty Domestic Gas cylinder of Bharat Petroleum each weight 14.2 kg.

(iii)03 (Three) Number of loaded Domestic Gas cylinder of HP each weight 29.8 kg.

I SI Raju Sarkar of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge the written complaint against accused person namely Satish Ch Roy S/O Lt Nagendra Ch Roy of Dangapara (Nowapara), PS- New Jalpaiguri, Dist-Jalpaiguri to the effect that on 24/09/2024 at about 08:35 hrs received a secrete source information that one Satish Ch Roy S/O Lt Nagendra Ch Roy of Dangapara (Nowapara), PS- New Jalpaiguri, Dist- Jalpaiguri is illegally storing and selling Domestic LPG cylinders i.e. HP and Bharat Petroleum at his house for the purpose of selling in open market without any valid license or documents for his wrongful gain. Hence I diarized the matter vide EB, SPC GDE No. 146 Dt. 24.09.24 and informed the matter to ACP EB, SPC and as per his instruction myself along with Inspector Samrat Mitra, ASI Arghya Das, C/924 Abhijit Kar all of EB, SPC left EB Office to proceed Dangapara (Nowapara), PS- New Jalpaiguri, Dist- Jalpaiguri to execute the information. This refers EB, SPC GDE No. 147 Dt. 05.09.24 and C.C. No. 66/24 Dt. 24.09.24.

At about 09:40 hrs we reached at Dangapara (Nowapara), PS- New Jalpaiguri, Dist- Jalpaiguri and contacted with source and being shown and identified by him, I along with officers and force conducted raid in the house of Satish Ch Roy of Dangapara and found that the above noted accused person is busy to selling HP and Bharat Petroleum gas. On searching, the above noted seized articles have been recovered from his house. On being asked the above noted accused person failed to produce any valid documents in support of above noted seized articles.

It is crystal clear that the said person namely Satish Ch Roy of Dangapara PS-New Jalpaiguri, Dist- Jalpaiguri is storing and selling the Domestic gas cylinders in his house for his wrongful gain. As per local enquiry it came to light that the above noted person storing and selling gas negligently with respect to fire or combustible matter, which may endanger human life or likely to cause hurt or injury to person at that locality area. Satish Ch Roy does not have any valid License/ Permit of dealing /distribution / selling LPG. Thus the above noted accused person violated the

provision of West Bengal Cooking Gas (License and Control) order 1985 and other Government Orders.

Accordingly I seized the above noted seized articles as per seizure list in presence of local witnesses namely 1)Goutam Das S/o Lt Haren das of Dangapara (Nowapara), PS- New Jalpaiguri, Dist- Jalpaiguri and 2) Arun Kr Roy S/o Lt Nagendra Nath Roy of Dangapara (Nowaapara), PS- New Jalpaiguri, Dist- Jalpaiguri. The seizure was made in between 10:25 hrs to 10:55 hrs.

Hence, I pray that a specific case may be recorded against the accused person namely Satish Ch Roy S/O Lt Nagendra Ch Roy of Dangapara (Nowapara), PS- New Jalpaiguri, Dist- Jalpaiguri and others
