With due respect, I am producing herewith the 02 (two) arrested accused persons namely 1) Bibek Biswakarma @ Bips (23), S/o- Bikash Biswakarma of Ring King Pong Road near Forest Compound, PO+PS+Dist- Kalimpong (A/P- Parijat Road, Salbari, PS- Pradhan Nagar, Dist-Darjeeling) and 2) Nimoy Thapa (25), S/o- Prabin Thapa of Alchikhop, PO+PS+Dist- Kalimpong (A/P- Parijat Road, Salbari, PS- Pradhan Nagar, Dist-Darjeeling).

I, PSI Avijit Banik, presently attached with Matigara PS under your kind control, beg to state that on 28.09.2024, during my night mobile van duty vide Matigara PS GDE No- 1553, Dt-28.09.2024, when myself along with force namely C/523 Sanjit Kundu, C/219 Sanatan Chitrakar all of Matigara PS, SPC were at City Centre under Matigara PS, at about 03.00 hrs, found that one small vehicle having registration no. WB 74 BL 2982 was standing in front of entry gate of Uttorayon suspiciously. Accordingly, myself along with the force went to near the vehicle and saw one couple doing personal acts inside the said car. On being asked, the boy, who was inside the car, called his friends over telephone. In a little while, 10 to 15 boys were came to the spot and started assaulting to us. As a result myself and other Police personnel got severe injury on our persons.
