Dear Sir/Madam,

The present complaint is being filed by SNV Aviation Private Limited, which runs an airline under the brand name 'Akasa Air' ("Akasa Air") and has its registered office situated at 12th Floor, Urmi Estate 95, Ganpatrao Kadam Marg, Lower Parel (West) Mumbai, Maharashtra – 400013. The complainant, Akasa Air, is represented through its authorized representative namely, Akumba Biswas, presently working as Duty Manager – Security at Akasa Air.

We wish to bring the following facts and circumstances to your kind attention:

 On October 15, 2024, it came to our attention that a user on social media website www.x.com (formerly Twitter), with the username '@schizobomber777' and screen name '@schizobomber 10' had posted a series of tweets threatening an Akasa Air Flight, specifically flight QP 1373 from Bagdogra to Bengaluru. These threatening tweets contained the following contents:

'@AkasaAir @SiliguriPolice @BlrCityPolice I placed explosives onboard of, Flight QP1373. Which: departed: from Siliguri and is Landing in Bensaluru, You will all die'

'@Lekhika836 @AkasaAir placed explosives onboard of, Flight QF1373. Which departed from Siliguni and s Landing Bengaluru. You will all die Alert police.'

'@AvglobeW @aviationbrk @flysrilankan @aaichnairport @MoCA\_GoI @DGCAIndia @airindia @omanair Gemirates @airasia @airarabiagroup @SingaporeAir @MAS eGulfAir Getihad @ gatarairways @Saudi Airlines @IndiGo6E @flyspicejet @AkasaAir @British Airways @lufthanaa @Mohan Rngnathan @flyingamit @CaptVilas @CaptShaktiLumba DaveWallaworth RajivSi53259510 @CaptPuneetNagi @Chopsyturvey mjavinod @nitinwelde @Chennaiflights placed explosives onboard of, Flight OP1373.  In response to these threats Akasa Air promptly escalated the matter to the representative of the Airports Authority of India (AAI). The Bomb Threat Assessment Committee (BTAC) was formed and following its assessment of the matter, the BTAC deemed that these threats were a 'specific threat'.

- 3. It is evident from the above, that this unknown person deliberately used these words to create disturbance and cause alarm. Such behaviour is not only unacceptable but also poses a serious security risk to the airport and its patrons. We urge your office to thoroughly investigate this matter and take swift action to ensure the safety and security of our passengers, crew and aircraft.
- 4. That in view of the facts and circumstances narrated above, the complainant humbly requests you to take necessary action against such unknown person, investigate the matter and if indeed found guilty, ensure the prosecution and punishment of the accused person in accordance with
