With due respect I, Arbind Kumar Mahato, Son of Shri Sakal Mahato, aged about 38 years, resident of Santoshi Nagar, Ward No. 05, Siliguri, P.O- Siliguri Bazar, P.S-Siliguri, District- Darjeeling, West Bengal, Pin- 734005 would like to inform you that today at about 09:00 am in the morning, my younger brother namely Rajiv Kumar Mahato, Son of Shri Sakal Mahato started to abuse my son namely Anant Mahato (07 years), Prashant Mahato (12 years) and my daughter namely Muskan Mahato (10 years). That all my sons and daughter are school going children and every day when they go to their school or tution, my younger brother namely Rajiv Kumar Mahato and his wife namely Paano Devi (nickname), uses to abuse them in filthy language.

That today when my children Anant and Muskan was on the way to meet me at my shop situated at Santoshi Nagar near Santoshi Mandir, Siliguri the said Rajiv Kumar Mahato started to abuse my children in filthy language and also slapped my daughter on her face. That both my children started to crying and narrated the whole incident to me.
