i.e Banned Sound Fire Crackers in the form of high decibel sound making fire crackers & different brands Fireworks having quantity total 16 kgs. approx. along with seizure list, alamat etc. I SI Raju Sarkar of Enforcement Branch, Siliguri Police Commissionerate do hereby submit suo-muto complaint to the effect that today 26.10.24 at 11:45 hrs received a source information, that one person without any valid permission or document made a stock of huge quantity of Banned Sound Fire Crackers in the form of high decibel sound making fire crackers & different brands Fireworks in Jaleswari Bazar Area and are trying to sale items to various customers. Accordingly, I diarised the matter vide EB, SPC GDE No. 143, dated 26.10.24 and brought it to the notice of ACP EB, SPC, about the information and as per his direction myself along with Inspector Samrat Mitra, ASI Arghya Das L/C 1270 Deeptina Gazmer and others staff all of EB, SPC left office to work out the source information at 12:15 hrs. At about 13:05 hrs on 26.10.24 we reached at Jaleswari Bazar, PS- Bhaktinagar & Dist- Jalpaiguri and as per identification of source we held raid at Maa Laxmi Narayan Lottery Agency & Prince Mobile Shop, PS- Bhaktinagar, Dist- Jalpaiguri and found the above noted Banned Sound Fire Crackers in the form of high decibel sound making fire crackers as per schedule of West Bengal Pollution Control Board. During enquiry it could be learnt that one Mala Dutta W/O Gopal Dutta of Shantinagar, PS-NJP, SPC A/P Mohim Colony Lane, Jaleswari, PS- Bhaktinagar, Dist- Jalpaiguri sales the above noted crackers and fire crackers for making good profit.

Thereafter I searched and seized procedure from that place in presence of local witness namely 1) Babla Das (45) S/O Lt. Niresh Das of Thakurnagar Jaleswari, PS- Bhaktinagar, Dist- Jalpaiguri and 2) Ram Gopal Sarkar (45) S/O Lt. Sadananda Sarkar of Hatiadanga, PO- Sahudangi, PS- Bhaktinagar, Dist- Jalpaiguri. During search of the place, I found huge quantity around 16 Kgs approx, as noted above of Banned Sound Fire Crackers in the form of high decibel sound making fire crackers & different brands Fireworks. Sales banned sound fire Crackers & Fireworks for selling locally for making good profit out of these.

As those sound crackers and fire crackers are banned vide various notification and directives of West Bengal Pollution Control Board including Memo No. 408-3L/WPB-R(VIII)/2015 dated 05.05.17. I seized the banned sound fireworks & fire crackers under proper seizure. Seizure was made between 13:20 hrs & 13:45 hrs as she violated the provisions laid down u/s 223/287 BNS & 24/26 West Bengal Fire Service Act 1950.

Under the above circumstances I pray before you that a specific case may kindly be started against *Mala Dutta W/O Gopal Dutta of Shantinagar*, *PS- NJP*, *Dist- Jalpaiguri A/P Mohim Colony Lane*, *Jaleswari*, *PS- Bhaktinagar*, *Dist- Jalpaiguri* u/s 223/287 BNS & 24/26 West Bengal Fire Service Act 1950 and other appropriate acts and sections of law and arrange for investigation of the case.
