

Sir,

In producing herewith two accused persons namely (i) Bikash Saha (48 yrs) & (ii) Ashok Saha (53 yrs) both are S/O Late Haripada Saha of Narmada Bagan, P.O- Champarasari, P.S- Pradhannagar, Dist- Darjeeling under arrest and following seized articles under proper seizure -

Cartoon No. 1: 39(Thirty Nine) Packets " Jugmug".

Cartoon No. 2: 166 Pieces " Joker" 21

Cartoon no. 3: 40 Packets Black Cat Chocolate Bomg 3)

Cartoon No. 4: 49 Packets Dulal's Chocolate. 4)

Cartoon No. 5&6: Lanka bomb.

I, SI- Mrityunjoy Roy of Matigara PS Siliguri Police do hereby lodged this written complaint against the above mentioned accused persons namely (i) Bikash Saha(48 yrs) & (ii) Ashok Saha (53 yrs) both are S/O Late Haripada Saha of Narmada Bagan, P.O- Champarasari, P.S- Pradhannagar, Dist- Darjeeling that during my morning patrolling van duty vide MCC No. 2830, Dated-26/10/2024 received a secret information that Bikash Saha & Ashok Saha has stored huge quantity of Fire-crackers at their shop at Simul Tala opposite IT Park under Matigara area for selling the same in the open market for their wrongful gain without having any license or other valid documents in respect of the same, violating the provision of law which may endanger human life and likely to cause injury of human life. Accordingly, I along with force rushed to the spot to work out the information.

On reaching at Simul Tala opposite IT Park, I contacted with my source and being identified by the source apprehended two persons with the above mentioned seized articles (Fire crackers) being stored in their shop, at Simul Tala under Matigara P.S, Siliguri Police Commissionerate . On interrogation they disclosed their identity as noted above.

Further, on demand they failed to produce any valid documents / license in support of the possession of such quantity of Fire crackers recovered from their shop. There is a reason to believe that Bikash Saha & Ashok Saha has stored the said consignment of fire crackers for selling the same in the open market for their wrongful gain, which are combustible in nature and endanger to human life and property at their shop at Simul Tala illegally and violating Govt. Orders, Moreover, the above noted fire crackers were stored without any precautionary and safety measures. Accordingly, I seized the above noted fire crackers under proper seizure list duly signed by the witnesses. The whole process of seizure was made in between 10.50 hrs to 11.10 hrs. Subsequently, I arrested the above noted accused persons namely Bikash Saha & Ashok Saha observing all the formalities and informing the ground of their arrest.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused persons namely (i) Bikash Saha(48 yrs) & (ii) Ashok Saha (53 yrs) both of them are the \$/O Late Haripada Saha of Narmada Bagan, P.O- Champarasari, P.S- Pradhannagar, Dist Darjeeling under proper section of law and arrange for its investigation.
