Sporting club, ward No. 25 under Siliguri PS with a view to sale the same to his customers for his wrongful gain. This information was diarised in Siliguri PS G.D.E No.1409 dated 28.10.24 and informed the fact to the I/C Siliguri PS. As per direction of I/C Siliguri PS, myself along with ASI Subir Sen, ASI Rabin Lama, C/160 Soumen Sarkar, all of Siliguri PS left for Milanpally near Sukanta Sporting club, ward No. 25 under Siliguri PS to verify the veracity of this information. This refers to Siliguri PS G.D.E No. 1411 dated 28.10.24. After reaching the place of occurrence we cordoned the place and as per identification by source, the above noted person was apprehended who disclosed his identity as noted above and after searching we found the above noted huge quantities of fire crackers was holding in his hand with a view to sell the same to the local people illegally for his wrongly gain. On being asked in presence of available witnesses the above noted
