In producing herewith following two accused persons namely 1) Sourav Natha Talukdar (31years) S/O Lt Sankar Nath Talukdar of Bottle company more, PS Bhaktinagar Dist Jalpaiguri, 2) Manish Saha (20years) S/O Sujan Saha C/O Santosh Tirki of bottle company ward no 41, PS Bhaktinagar Dist Jalpaiguri along with following seized articles-

1) 08 (eight) bundles of Rhino power chocolate bomb each bundle containing five sub packet.

2) 08 (eight) packet pop of pop wrinkles.

3) 07 (seven) packets of leopard king crackers each containing ten pieces.

4) 08 (eight) bundle of electric sparkle each bundle containing two sub packet.
5) 10 (10) pieces of 3 in 1 super light cracker manufactured by cipla fire box WB.

6) 02 (two) packets of giant crackers.

I, ASI Dhruba Misra S/O Abani Misra of Bhaktinagar, Siliguri Police Commissionerate do hereby lodged this written complaint against the above mentioned accused persons namely Sourav Natha Talukdar and Manish Saha to the effect that today on 28.10.2024 at 13.25 hrs received a secret information that huge quantity of Fire-crackers has been stored at the rented house of Manish Saha C/O Santosh Tirki which is located at bottle company ward no 41, PS Bhaktinagar Dist Jalpaiguri for selling the same in the open market for wrongful gain without having any license or any other valid documents in respect of the same, violating the provision of law which may endanger human life and likely to cause injury of human life. This refers to Bhaktinagar PS GDE No- 1481/24 dated 28.10.2024 Accordingly, as per your kind order I along with SI Srimanta Chatterjee, SI Rantu Haldar, SI Youel lepcha, ASI- khagen Barman, C374 Debraj Biswas all of Bhaktinagar PS, SPC rushed to the spot to work out the information. On the way to bottle company under Bhaktinagar PS.

I summoned two disinterested witnesses namely 1) santosh Tirki S/O Lt Balaram tirki of bottle company more, PS Bhaktinagar Dist Jalpaiguri, 2) Ranjit Gope S/O Subal Gope C/O Rajib Kundu bottle company, PS Bhaktinagar Dist jalpaiguri, apprised them about the information in hand and on request they agreed to accompany us in the whole raid, search and seizure process if required.

On reaching there I contacted with my source and being indicated by the source I conducted raid at the said house and apprehended two persons with the above mentioned seized articles (Fire crackers) which was stored at his house. On interrogation they disclosed their identity as noted above.

B.K.N-PS/8.P c 21-28/10/2024 Further, on demand they failed to produce any valid documents/ license in support of the possession of such quantity of Fire crackers recovered from the rented house of Manish Saha C/O Santosh Tirki which is located at bottle company ward no 41, PS Bhaktinagar Dist Jalpaiguri.

There is reason to believe that Sourav Natha Talukdar and Manish Saha have stored the said consignment of fire crackers which are combustible in nature and endanger to human life and property, violating Govt. Orders Moreover, the above noted fire crackers were stored without any precautionary and safety measures and thus, violated the section 287/288 of BNS. Accordingly, I seized the above noted fire crackers under proper seizure list duly signed by the witnesses and acknowledged by the accused persons namely Sourav Natha Talukdar and Manish Saha. The whole process of seizure was made between 15.05hrs to 15.30hrs and covered under proper audio video records as per norms. Subsequently, I arrested the above noted accused persons namely Sourav Natha Talukdar and Manish Saha observing all the formalities and informing the ground of their arrest.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the following accused persons namely 1) Sourav Natha Talukdar (31years) S/O Lt Sankar Nath Talukdar of Bottle company more, PS Bhaktinagar Dist Jalpaiguri, 2) Manish Saha (20years) S/O Sujan Saha C/O Santosh Tirki of bottle company ward no 41, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for its investigation.
