

In producing herewith following four (04) accused persons namely 1) Biswajit Sarkar (M/27yrs) S/O- Parimal Sarkar of Amtala, Bottle Company, near Kali Mandir W.No- 41, PS-Bhaktinagar, Dist- Jalpaiguri 2) Jyotish Haldar (M/28yrs) S/O- Lt Haradhan Haldar, of Amtala, Sastrinagar, Bottle Company, near Kali Mandir W.No- 41, PS- Bhaktinagar, Dist-Jalpaiguri. 3) Rahul Hossain (M/23yrs) S/O- Nazrul Miya of Samarnagar, Battala, Ganga Mandir, PS- Pradhan nagar, Dist- Darjeeling. 4) Rajib Adhikary (M/22yrs) S/O- Subal Adhikary of Prakash nagar, Dada vai Colony, W.No-43, PS- Bhaktinagar, Dist- Jalpaiguri with following seized articles viz:

1) One sharp cutting iron made knife length measuring approx 12 cm, recovered from the possession of Rajib Adhikary.

2) One iron made hacksaw blade length measuring 10 cm recovered from the possession

of Rahul Hossain.

3) One iron made sharp cutting knife length measuring approx 6cm recovered from the possession of Biswajit Sarkar.

4) One Sharp cutting iron made knife length measuring approx 12 cm recovered from the

possession of Jyotish Haldar.

I, ASI Dipak Karmakar (8906402165) S/O lt Dulal Karmakar of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 1) Biswajit Sarkar 2) Jyotish Haldar. 3) Rahul Hossain. 4) Rajib Adhikary and 6/7 others to the effect that on 07.11.2024 at 00:10 hrs received a specific source information that 10/11 miscreants have assembled at Donbosco more under Bhakti Nagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C Bhakti Nagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No 331/24 dated 07.11.2024 and as per order I along with SI Srimanta Chatterjee, SI Rantu Haldar, SI Youel Lepcha, ASI Khagen Barman, C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for Donbosco more under Bhakti Nagar PS, to work out the information in hand.

At about 00.25 hrs we arrived at Donbosco more under Bhakti Nagar PS, as indicated by the source we noticed that 10/11 persons assembled at Donbosco more under Bhakti Nagar PS, and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party somehow managed to apprehended above noted 04 (four) of them with deadly weapons in their possession but 6/7 persons managed to fled away from the spot taking the advantage of darkness and open place.

On interrogation the apprehended accused persons disclosed their name and identity noted above and also stated that they were present there along others and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 07.11.2024 in between 00.45 hrs to 01.25 hrs. The whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against following accused persons namely 1) Biswajit Sarkar (M/27yrs) S/O- Parimal Sarkar of Amtal, Bottle Company, near Kali Mandir W.No- 41, PS- Bhaktinagar, Dist- Jalpaiguri 2) Jyotish Haldar (M/28yrs) S/O- Lt Haradhan Haldar, of Amtala, Sastrinagar, Bottle Company, near Kali Mandir W.No- 41, PS-Bhaktinagar, Dist-Jalpaiguri. 3) Rahul Hossain (M/23yrs) S/O-Nazrul Miya of Samarnagar, Battala, Ganga Mandir, PS- Pradhan nagar, Dist- Darjeeling. 4) Rajib Adhikary (M/22yrs) S/O- Subal Adhikary of Prakash nagar, Dada vai Colony, W.No-43, PS- Bhaktinagar, Dist-Jalpaiguri and others kindly arrange for its investigation
