On 22.11.2024 at about 12:55 hours, I, Sri Sourav Paul, DE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Bijay Lakra, DE (E), 2. Mr. Bhaben Roy, Special Officer, both attached with S&LP unit, Darjeeling Region Office, WBSEDCL & 3. Mr. Arnab Ray, J.E. (E) (Grade-II) & 4. Mr. Biplab Sarkar, Sr. OE, attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises of Mr. Dipak Saha, S/O- Chittaranjan Saha, Address: Purba Majhabari (near Jermel's School), P.O. – Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 400471155), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During inspection, the aforesaid accused, Mr. Dipak Saha, S/O- Chittaranjan Saha, Address: Purba Majhabari (near Jermel's School), P.O. - Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 400471155), was found consuming Electricity dishonestly in unauthorized manner by Unauthorized Reconnection of the 'Deemed Disconnected' service connection having Consumer ID: 400471155 & Meter No.: G02329850 which was disconnected on 10.12.2021 due to having outstanding dues of electricity of Rs. 5,308.00 by that time (excluding LPSC). Moreover, the last meter consumption up to which billing was raised is 3698 kWh. Moreover, during inspection on 22.11.2024, the said energy meter was found 'Defective due to Meter Stop/Reverse Reading' & the service connection was found 'Physically Live' & consuming electricity at his aforementioned Domestic premises for Domestic purposes having Accessed/Inspected Load 1.0 kW. Thus the service connection was used in unauthorized manner & no further billing could have been possible, because of which WBSEDCL

As the unauthorized use had been detected I immediately with the help of my Technical staff disconnected his Service Connection and seized one number single phase Energy Meter with P.P. Box having device SI No.: G02329850, make: Genus, Rating: 240V, 5-30A, 50Hz, 3200 imp/kWh (L.R.: Defective) connected with some portion of Incoming & Outgoing wires which have been used for Unauthorized Reconnection of the 'Deemed Disconnected' service connection (Consumer ID: 400471155) & consuming electricity dishonestly in unauthorized manner in the aforementioned Domestic premises for the Domestic purposes under a proper seizure list as well as the seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities in presence of the Inspection Team Members & Witnesses & Representative (i.e. wife) of the Accused Person. The inspection team members left the aforesaid premises at 13:30 hours on the same day after observing all
