

Subject: F.I.R

With due respect and humble submission I ASI Abdul Latif of Matigara P.S do hereby lodge this written complaint to the effect that today on 22-23/11/2024 I was deputed to perform morning /night Mobile Patrol duty along with force, since 08:00 hrs to 14:00 hrs (22/11/24) again from 22:00 hrs to 10:00 hrs (22-23/11/24) vide Matigara P.S. C.C. No- 3105, Dated - 22/11/2024, This refers to Matigara P.S. GDE No 262 Dated 22/11/2024. At about 08:05 hrs, in course of said mobile van duty I received source information that 02 no. of vehicle loaded with illegal river bed materials are coming from Rana Nagar Ghat towards Matigara. This is to be noted here that an order has already been passed by the District Magistrate, Darjeeling to stop all mining operations on River bed during Monsoon season, vide No. 62/M&M/XIII/DLLRO-DJ/24, Dated 28/06/24. The order is still in force.

On receipt of such information, I along with my accompanied force rushed to Sutki Godown and found that vehicle no. WB 73 A/7789 (Tata Truck) & vehicle no. WB- 73 G 4426 (Tractor with trolley) loaded with river bed materials coming from Patiramjote side. Seeing the Police team labor and driver of the vehicle fled away from the spot leaving the vehicle abandoned. I tried hard to search the driver or owner of the said vehicles loaded with such river bed materials, but failed. It is evident that driver/owner of the vehicle somehow procured the said river bed materials clandestinely, violating Govt. Order, also without paying any revenue to the Govt.

Finding no other alternatives, I seized vehicle no. WB 73 A/7789 (Tata Truck) & vehicle no. WB-73 G 4426 (Tractor with trolley) loaded with river bed materials under proper Seizure List in presence of local people under coverage of Videography, also brought the seized vehicle at P.S. The seizure was made in between 08:30 hrs to 08:45 hrs on 23.11.2024.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the unknown accused driver / owner of the seized vehicle and arrange for its investigation.
