Sir,

With due respect and humble submission I SI Sabin Yonjon Tamang of Matigara P.S do hereby lodge this written complaint to the effect that today on 24/114/2024 I was deputed to perform evening Mobile Patrol duty along with force vide Matigara P.S. C.C. No-3133/24, Dated – 24/11/2024, This refers to Matigara P.S. GDE No-1307, Dated 24/11/2024. At about 21:30 hrs, in course of said mobile van duty I received source information that one vehicle loaded with illegal river bed materials is standing at Bashbari Ghat, under PS- Matigara. This is to be noted here that an order has already been passed by the District Magistrate, Darjeeling to stop all mining operations on River bed during Monsoon season, vide No. 62/M&M/XIII/DLLRO-DJ/24, Dated 28/06/24. The order is still in force.

On receipt of such information, I along with my accompanied force rushed to Bashbari Ghat and found that vehicle no. WB 74 BP 9836 (Tractor with trolley) loaded with river bed materials is standing at Bashbari Ghat. Seeing the Police team labor and driver of the vehicle fled away from the spot leaving the vehicle abandoned. I tried hard to search the driver or owner of the said vehicle loaded with such river bed materials, but failed. It is evident that driver/owner of the vehicle somehow procured the said river bed materials clandestinely, violating Govt. Order, also without paying any revenue to the Govt.

Finding no other alternatives, I seized vehicle no. WB 74 BP 9836 (Tractor with trolley) loaded with river bed materials under proper Seizure List in presence of local people under coverage of Videography, also brought the seized vehicle at P.S. The seizure was made in between 21:45 hrs to 21:55 hrs on 24.11.2024.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the unknown accused driver / owner of the seized vehicle and arrange for its investigation.
