In producing herewith four (O4) accused persons namely 1.Suraj Sahani (21) S/O Bindi Sahani of Nabagram near winners Club PS NJP Dist. Jalpaiguri 2. Prosenjit Das@ Bura (24) S/OLt. Paresh Ch Das of Gate Bazar, Near SBI Bank PS NJP Dist. Jalpaiguri 3. Riju Majumder@Saheb (19)S/O Nirmal Majumder of Surya Sen Colony PS. NJP Dist. Jalpaiguri 4. Md. Salman (29) S/O Md. Irfan Ali of Tinbati Colony PS. NJP Dist. Jalpaiguri along with seized articles viz

- One improvised twelve Bore fire arms measuring approx 11.5 inches in length which consists 7 inches barrel, 2.5 inches butt and 2 inches body, firing pin from the possession of . Prasenjit Das@ Bura.
- 2. One piece of twelve bore live ammunition from the right side pocket of pant of Prasenjit Das
- One iron made weapon called as "Sword" measuring approx 2' feet and 9 inches metel butt from the possession of. Md. Salman
- One iron made weapon called as Hasua measuring approx 2 feet including butt from the possession of Suraj Sahani
- One iron rod measuring approx 1½ feet from the possession of accused person Riju Majumder@Saheb
- One Salai Rinch approx length 1 feet from the PO
- one Electronic torch light from the PO.

I SI Ganesh Roy of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 7/8 persons to the effect that on the night 19.11.24 at 22.25 hrs received secret source of information to the effect that some miscreants, being armed with deadly weapons assembled in a dark place at Fulbari , near Mahananda Barage under NJP PS with a view to commit dacoity. Accordingly without wasting time I informed the matter to you and duty officer of PS and as per your kind direction myself along with, ASI Nilam Swarnakar, ASI Monaj Majumder C/1462 Sajan Tamang, VP-13 Jamirul Islam left from PS which noted in GD vide NJP PS GDE No. 1092 dt. 19.11.2024 with night mobile van officer ASI Paresh Nath Choudhury and C/1520 Samir Adhiary NVF68 Amit Roy for Fulbari, near Mahananda Barage to verify the veracity of the information and to work upon it . We reached near the spot as confirmed by the source on 19.11.24 at 22.45 hrs and stopped our vehicle at a considerable distance from that place and we started walking towards the said place and we reached near the place and found a group of 11/12 persons assembled and gossiping in a dark place at that area. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of them saw the police and tried to flee away from there. Somehow, after a hot chase we could able to apprehend the four (04) persons noted above and the others 7/8 persons managed to flee away from the spot. On interrogation they disclosed their identity which not verified and they also stated that they alongwith their other associates assembled there with a view to commit dacoity after making full preparation at Fulbari Bazar and adjacent area under NJP PS.

Thereafter all the apprehended persons were searched and due to late night could not found any independent witness to present at the time of search and seizure. During searching I found and recovered some sharp cutting deadly weapons mentioned above and also one improvised fire arms with ammunition which they were carrying illegally without any valid documents/license from their conscious possession as well as Place of occurrence, accordingly I seized the same as per proper seizure list duly sign by them and the process of search and seizure as been captured in videography as per provision of law. Accordingly I arrested the above noted 04 accused persons u/s 35 BNSS. The seizure and arrest made on 19.11.24 in between 23.10 hrs to 23.25 hrs and the all persons were arrested with proper memo of arrest.

So I pray before you that a specific case may kindly be started against 1.Suraj Sahani (21) S/O Bindi Sahani of Nabagram near winners Club PS NJP Dist. Jalpaiguri 2. Prosenjit Das@ Bura (24) S/OLt.
