1. That I am a Tea cum retail lottery hawker having my stall at Nauwapara, opposite Aparna Group Company, P.O. Sahudangi, P.S. NJP, Dist. Jalpaiguri since six months peacefully and honestly. One **Mousumi Das**, daughter of Sri. Paresh Das, permanent resident of Bashbari, Ramnagar, P.O. Sahudangi, P.S. N.J.P., Dist. Jalpaiguri, is my employee/assistant who helps me in running my above mention business.

2. That on 15.12.2024 at about 4.30 P.M. one customer namely **1. BUBAI ROY**, son of "not known", permanent resident of Vill. Shantipara P.O. Sahudangi, P.S. NJP, Dist. Jalpaiguri came along with one private OMNI van bearing Regd. No. **WB 60 L-1696** in my stall at Nauwapara, beside Aparna Group Company, P.O. & P.S. NJP, Dist. Jalpaiguri, for buying cigarette. While he was standing in front of my stall and smoking he called his five more friends namely **2. DARSHAN ROY**, son of "not known", **3. RAJU ROY**, son of Sri. Kanai Roy, both are residents of permanent resident of Dabgram, Nauwapara, P.O. Sahudangi, P.S. NJP, Dist. Jalpaiguri, **4. KHOKON ROY**, son of "not known", permanent resident of Telenipara, P.O. Sahudangi, P.S. NJP, Dist. Jalpaiguri, **5. & 6. "NOT KNOWN"**, son of "not known", residential addresses "not known", who were inside the above mentioned OMNI van, came in front of my stall and started to make sexual and offensive comments to my above named employee namely Mousumi Das and even offered to show the sizes of their Penis. When I immediately lodged a verbal protest to them and told them to leave the place immediately or I shall lodge a complaint against them before the police all of them suddenly got furious and started to brutally assault me on my persons with fists and kicks. All of them took out iron rods and knives from their OMNI van and unrestrained attacked me on my persons by saying that **"today you will not remain alive"** in the presence of local people. As result due to my tremendous bleeding I lost my consciousness. Seeing this when my employee came to rescue me from their hands all the above six (6) persons tore her clothes and assaulted her physically with fists and blows and tried to forcefully take her inside their OMNI Van but she anyhow escaped from their hands and fled away to inform my father. Meanwhile all the above persons looted my stall by taking away all the items and also took Rs. 20,000/- cash from the drawer of my stall. When my employee returned on the spot again along with my father all of them again assaulted my father. All the above named persons threatened us if we continue the hawker business or inform this incident to police then they will kill all three of us next time and then they left the spot. Later we were admitted to the Siliguri Sadar hospital by the help of local people. At present we all are under treatment.

3. That I came to know from the local people that all the above named persons are anti-socials. No one dares to mess with them.

I therefore request you to kindly take necessary legal steps against **1. BUBAI ROY**, **2. DARSHAN ROY**, **3. RAJU ROY**, **4. KHOKON ROY**, **5. & 6. "NOT KNOWN"**. I shall be highly obliged to you forever.
