<u>Sub - Complaint against Jagannath Roy and Anil Barman for criminal breach of trust, cheating, extortion, and criminal intimidation causing distress and mental agony.</u>

Sir,

I, Amitabha Basu, Son of Late Debabrata Bose, resident of Raktakarabi, South Deshbandhu Para, Gyanprakash Ghosh Sarani, P.O. Siliguri Town, P.S. Siliguri, Dist - Jalpaiguri, Pin code - 734004 wish to draw your kind attention to the following:-

- 1. That one Ganesh Roy and Jagannath Roy, both are son of Late Nalini Roy were the lawful owners of a land measuring about 21 Kathas in Mouza Binnaguri, Sheet No. 4 by dint of a Deed being No. I 2362 for the year 2005 registered at the Office of the Sadar Joint Sub Registrar of Jalpaiguri at Rajganj. In this deed seven plots being no. 372, 375, 377, 378, 379 and 380 were mentioned, but possession was delivered within specific boundary.
- That subsequently on 08.06.2013 I had purchased a land measuring about 4 Kathas 12
   Chhataks from said Ganesh Roy and Jagannath Roy by virtue of a Deed of Conveyance being I- 5985 for the year 2013, registered at the Office of the Additional District Sub Registrar, Rajganj.
- 3. That before purchasing this property one Samir Dutta, P. Amin (Surveyor), having Trade Registration No. 2045/12, Dabgram 2 was engaged to identify the correct plot in which the possession was delivered to me. This surveyor has identified the plot number to be 377. Accordingly Plot number was mentioned as 377 in my deed and the sketch map annexed with the deed.
- 4. That Later it has discovered that the Plot number of my land is 375 and not 377. Since the title deed of my vendors consisted both the plot nos. 375 and 377, such error in my title deed can be rectified by way of a Deed of Rectification to be executed by said Ganesh Roy and Jagannath Roy.
