In producing herewith 04 (four) arrested accused persons namely (1) Rabi Pradhan @ Raghu-37yrs s/o Lt Kalu Pradhan of Choto Fapri, near school, PS Bhaktinagar Dist Jalpaiguri (2) Parimal Ghosh-36yrs s/o Lt Bashhu Ghosh of Iskcon road, near Maszid ward no-40 PS Bhaktinagar Dist Jalpaiguri (3) Biki Nag-26yrs s/o Nandalal Nag of Durganagar Iskcon road ward no-40 PS Bhaktinagar Dist Jalpaiguri and (3) Ram Das -31yrs s/o Subhash Das of Kholachand fapri near Loknath Mandir PS Bhaktinagar Dist Jalpaiguri arrested on 19.01.25 u/s- 35 (1) BNSS along with following seized articles viz: -

- 1. One iron made screw driver having length approx 13 inch recovered from the exclusive and Conscious possession of Ravi Pradhan @ Raghu which was kept on his right hand.
- 2. One iron made sharp cutting knife having length approx 13 inch with plastic butt which was recovered from the exclusive and Conscious possession of Biki Nag.
- 3. One iron made hammer having length approx 14 inch which was recovered from the possession of Parimal Ghosh.

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 19.01.25 at 22.35 hrs received a sources information that 11/12 youths have assembled at P.C Mittal bus stand, near Tower under Bhaktinagar PS for making preparation to commit dacoity in a house at Bhaktinagar PS area. The fact was diarized in G.D vide Bhaktinagar PS GDE No. 1046 dated 19.01.25 subsequently after sharing the information with my superiors and as per their direction, at == hrs myself along with ASI Dhrubo Mishra, C/374 Debraj Biswas and PS Van officer ASI Pasang Dawa Sherpa with force (K-37) along with kits left for the place to work out the information. This refers to Bhaktinagar PS GDE No- 1047 dated 19.01.25. We reached near P.C Mittal bus stand, near Tower under Bhaktinagar PS at 22.50 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 04 (four) accused persons along with seized articles as mentioned above. However, the other 5/6 persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Bhaktinagar PS area. They also stated that another six others fled away from the spot.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made in between 23.10 hrs to 23.45 hrs) Thereafter, I arrested the above noted accused persons u/s 35(1) of BNSS under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them. Seizure process duly audio & video graphed.

I accordingly brought the arrested accused persons along with seized article at Bhaktinagar Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit Dacoity in a house at Bhaktinagar PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. namely (1) Rabi Pradhan @ Raghu-37yrs s/o Lt Kalu Pradhan of Choto Fapri, near school, PS Bhaktinagar Dist Jalpaiguri (2) Parimal Ghosh-36yrs s/o Lt Bashhu Ghosh of Iskcon road, near Maszid ward no-40 PS Bhaktinagar Dist Jalpaiguri (3) Biki Nag-26yrs s/o Nandalal Nag of Durganagar Iskcon road ward no-40 PS Bhaktinagar Dist Jalpaiguri and (3) Ram Das -31yrs s/o Subhash Das of Kholachand fapri near Loknath Mandir PS Bhaktinagar Dist Jalpaiguri and 5/6 others and arrange for its investigation.
